

ORDINANCE No. 187572

Authorize a contract with the lowest responsible bidder for construction of the Fanno Basin Pressure Line System Upgrade Project No. E10599 for an estimated cost of \$1,173,000 (Ordinance)

The City of Portland ordains:

Section 1. The Council finds:

1. The Bureau of Environmental Services (BES) has a need to upgrade the Fanno Basin (FABA) pressure line system to provide long-term reliability.
2. The level of confidence in the estimated cost for a construction contract for the FABA Pressure Line System Upgrade project is high.
3. The estimated cost is \$1,173,000. Funds are available in the Sewer System Operating Fund, FY 16 Budget, Bureau of Environmental Services, WBS E10599.

NOW, THEREFORE, the Council directs:

- a. The Commissioner-in-Charge is authorized to execute a contract for the purpose described in Section 1, with the lowest responsive bidder.
- b. The Mayor and City Auditor are hereby authorized to pay for the contract from the Sewer System Operating Fund Budget.


