This group asks to be placed on the agenda of the City Council meeting, Wednesday, October 14, 1970. They want assurance that the removal process will permit them to move with dignity and will not force them to go into debt or suffer financial loss.

The Portland Community Relations Committee of AFSC has made part of my time available to the Emanuel Displaced Persons Association as a resourse or staff person and we are working with this group.

Inclosed are copies of two petitions being circulated in the area and in supportive areas. Please advise an approximate time the group could make a brief presentation next Wednesday, so community people can arrange to be present.

removal from the Emaneul Hospital Project.

We request the City Council and the Mayor to urge the Portland Development Commission, who is the agency dealing with the residences, to make every effort to see that those removed do not suffer financial loss and are able to make the move with dignity. Such action on the part of the City Council now will relieve some of the tension in the community.
