

ORDINANCE No. 81591

An Ordinance transferring the sum of \$1,931.00 from the General Fund appropriation Emergency & Unforeseen Expenditures to the General Fund appropriation Property for Widening and Right-of-Way, account of the opening and extension of North Carey Blvd.; authorizing the drawing of a warrants and declaring an emergency.

The City of Portland does ordain as follows:

Section 1. The Council finds that, by Resolution No. 22690, adopted August 30, 1945, the City Engineer was directed to prepare a written report on the opening and extension of North Carey Boulevard from the northerly line of North Willamette Blvd. to the southerly line of North Walker Street; that said report has been filed with the Council and it has been determined that it will be necessary to purchase certain parcels of property for the opening and extension of North Carey Boulevard; that the purchase of said parcels of property amounts to \$1,931.00;

Now, therefore, the sum of \$1,931.00 be and the same is hereby transferred from the General Fund appropriation Emergency & Unforeseen Expenditures (4100.) to the General Fund appropriation Property for Widening and Right-of-Way (4650.);

Section 2. That the Mayor and Auditor be and they hereby are authorized to draw a warrant in the sum of \$1,931.00 in favor of the City Treasurer to be placed by him to the credit of the fund for the opening and extension of North Carey Boulevard.

Section 3. Inasmuch as this ordinance is necessary for the immediate preservation of the public health, peace and safety of The City of Portland, in this: It is necessary that said fund for the opening and extension of North Carey Boulevard be completed without delay; therefore, an emergency is hereby declared to exist; and this ordinance shall be in force and effect from and after its passage by the Council.
