

ORDINANCE NO. 187 579

* Authorize an agreement with the Multnomah County Sheriff's Office in the amount of \$30,000 to provide internal and external security for the IAAF World track and field games (Ordinance)

The City of Portland ordains:

Section 1. The Council finds:

1. The City of Portland in conjunction with USA Track and Field and The United States Olympic Committee are holding the 2016 World Indoor Track and Field Championships in Portland Oregon.
2. This event will run from March 17 to March 19, 2016. It is the premier indoor championship for track and field in the world.
3. It is anticipated that over 600 athletes from 200 countries will participate and over 6,000 US and international spectators will attend this event.
4. Several hundred members of the national and international media will also be there to cover the event and broadcast it to over 180 countries and 140 million viewers.
5. A key component in accomplishing a successful event is the security mission, which is to provide proactive security as well as a robust incident and emergency response system.
6. Resources for safety and security are limited. The size and scope of this event dictates a higher level of physical security that stretches beyond bureau resources.
7. The Police Bureau has requested assistance of the Rapid Response Team of the Multnomah County Sheriff's Office in support of the 2016 event.
8. The cost of this assistance is estimated not to exceed \$30,000.
9. Sufficient funding resides in existing FY 2015-16 Police Bureau appropriation.
10. It is beneficial to the City and community that this agreement may be authorized as quickly as possible to prepare for this large scale event.

NOW THEREFORE, The Council directs:

- a. That the Commissioner-in-charge is authorized to execute an agreement between the City and Multnomah County as outlined in a form similar to the contract attached as Exhibit A, at a cost not to exceed \$30,000.
- b. The Mayor and the Auditor hereby are authorized to pay for the contract from the FY 2015-16 Budget.

- c. The Chief of Police is authorized to execute amendments to the scope of services or the terms and conditions of this Agreement, provided the changes do not increase the amount of compensation or increase the City's financial risk.

Section 2. The Council declares that an emergency exists because this agreement should be in place well before the event to allow time for coordination and planning. Therefore this ordinance shall be in full force and effect from and after its passage by the Council.


