## ORDINANCE No. 187584

\*Amend agreement with Resolutions Northwest in the amount of \$28,000 for restorative justice services in the Parkrose School District. (Ordinance; amend Contract No. 38117)

The City of Portland ordains:

Section 1: The Council Finds:

- 1. In November 2015 during the Fall Budget Monitoring Process, Council authorized \$28,000 in the FY 2015-16 Revised Budget for the to fund restorative justice services provided by Resolutions Northwest (RNW).
- 2. In the regular budget process for FY 15-16, the Council approved funding the extension of the agreement between the Office of Neighborhood Involvement and RNW to provide community-based mediation and facilitation services through June 30, 2016 (Grant Agreement No. 38117).
- 3. The Office of Neighborhood Involvement has administered the RNW grant agreement with the addition of restorative justice services in past years. In the FY 15-16 Spring Budget Monitoring Process the Mayor's Office intends to transfer those funds to the Office of Neighborhood Involvement. Staff recommends amending the current ONI grant agreement with RNW to include the funding for restorative justice services.

NOW, THEREFORE, the Council Directs:

a. The Director of the Office of Neighborhood Involvement is authorized and directed to amend the current Grant Agreement No. 38117 in a form substantially similar to that attached as Exhibit A.

Section 2. The Council declares an emergency exists in order to maintain the restorative justice services provided to the community through this amendment; therefore, this Ordinance shall be in full force and effect from and after its passage by the Council.
