

ORDINANCE No. 187606

* Authorize Amendment 16 to Intergovernmental Agreement with Multnomah County to provide maintenance services west of the Willamette River for FY 14-15 (Ordinance; amend Contract No. 51062)

The City of Portland ordains:

Section 1. The Council finds:

1. The City of Portland (City) has provided road and drainage services to certain areas of unincorporated Multnomah County (County), via Ordinance No.155651 passed by Council on March 1, 1984.
2. The original service agreement did not provide for financial remuneration to the City because the areas were to be annexed to the City. However, annexation of the western areas has been slower than anticipated in 1984; and the County has been informed that the City can longer provide services without financial remuneration.
3. Both the City and the County agree that it is most efficient for the City to continue providing road and drainage facility maintenance to these areas via Ordinance No. 177777, passed by Council on August 13, 2003.
4. Amendment 16 amends the agreement for FY 14-15. Approval of this amendment provides administrative continuity in contract amendment numbering for this intergovernmental agreement with Multnomah County.
5. The Bureau's level of confidence in the cost estimates for these amendments is optimal because the work has been completed.

NOW, THEREFORE, the Council directs:

- a. The Mayor is hereby authorized to execute Amendment 16 to Contract No. 51062 with Multnomah County to provide financial remuneration for maintenance services to certain county roads west of the Willamette River, in a form similar to the contract attached as Exhibit A.


Section 2. The Council declares that an emergency exists because the fiscal year for this amendment has been completed and approval of this amendments allows for future amendments to be acted on; therefore, this Ordinance shall be in full force and effect from and after its passage by the Council.
