SUBJECT: Accept Report on New Portland Fire & Rescue Duty Uniforms

I am pleased to submit for your consideration and acceptance the new Portland Fire & Rescue Duty Uniform.

Like most sworn professions, PF&R has a long standing tradition of uniforms that represent our identity, professionalism, and Esprit di corps. Our uniform is symbolic not only of the training and skills we possess, but also of the trust the public places in us. Our uniform is our pass to walk into someone's home on their worst day and they recognize us as worthy of their trust and respect. Our uniform is something we wear with pride and always protect.

Unfortunately, our current Duty uniforms do not meet the NFPA 1975 safety standards. In order to meet NFPA safety standards and to reduce uniform replacement costs, the Logistics Section in conjunction with the Uniforms Committee, recommended a Duty uniform change to NFPA-compliant Nomex uniforms.

A wear test was completed and the LION StationWear<sup>TM</sup> was selected. Our new Duty uniform consists of black Nomex pants with our current blue tee-shirt/sweatshirt, and our current blue Bravo shirt will be replaced with a black Bravo shirt made of Nomex. When wearing the black Bravo shirt, members will continue to wear the blue tee-shirt underneath. 40-hour Chief Officers will continue to wear white Bravo shirts, and 40-hour Staff Officers/Inspectors will have the option of wearing either the black or white Bravo shirt, unless otherwise directed by their respective Division Chief for a specific occasion.


Logistics has begun delivery of the new uniforms and will hopefully complete this process by the end of March.


