## ORDINANCE No. 91511

An Ordinance authorising the drawing and delivery of a warrant in the sum of \$65.00, payable to Marguerite Campbell, in payment for a right of way easement and settlement of a claim, and declaring an emergency.

The City of Fortland does ordain as follows:

Section 1. The Council finds that the City Engineer has arranged for certain right-of-way as herein described; that \$1,65.00 is a fair amount to be paid under the circumstances; that payment should be made and the deed for said right of way secured; now, therefore, the Mayor and Auditor hereby are authorized and directed to draw and deliver a warrant in the sum of \$1,65.00 payable to the said Marguerite Campbell following examination of title reports as to said property and approval thereof by the City Attorney: 1,70 Lineal Feet of 10 foot right of way and damages through a portion of Section 17, Tals. R. Le., Wale, said warrant to be drawn against and charged to account No. 1,650.680 - Property for Widening and rights of way.

Section 2. The warrant authorized in Section 1 hereof shall be delivered to the said Marguerite Campbell upon her filing with the Auditor of the City of Portlania full and complete release of all claims, approved by the City Attorney as to form.

Section 3. Inasmich as this ordinance is necessary for the immediate preservation of the public health, peace and safety of the City of Portland in this: In order that there may be no unnecessary delay in the conclusion of this transaction, therefore an emergency is declared to exist and this ordinance shall be in force and effect from and after its passage by the Council.
