ORDINANCE NO. _91769

An Ordinance to declare the annexation of certain areas to the City of Portland, providing for the change in boundaries of the City as set forth in the Charter, as required by the annexation election, and declaring an emergency.

The City of Portland does ordain as follows:

Section 1. It appearing to the Council that qualified electors in the separate areas in this section described, pursuant to Ordinance No. 91212, passed by the Council on February 16, 1950, voted upon the question of whether such areas should become annexed to the City of Portland on the 4th day of April, 1950, and that gualified voters of the City of Portland, pursuant to the same ordinance, voted upon the same question on the 19th day of May, 1950, in the manner prescribed by law; that the official canvass of the results of such election shows that a majority of voters voting upon said question in each of the areas in this section de-scribed and a majority of the voters voting upon said question in the City of Portland, respectively, voted in favor of annexing each of such areas to the City of Portland, and it further appearing to the Council that all of the required procedure set forth in Chapter 210, Oregon Laws 1949 has been complied with; now, therefore, said areas designated separately below by the numbers by which they were designated at said elections, each of which areas is described as follows:

ANNEXATION PROPOSITION NO. 1.

Beginning at the point of intersection of the west line of SW Dosch Road and the Portland City boundary in the north line of Section 17, T. 1 S., R. 1 E. W. N.; then south 6° 07' 30" east tracing the west side of SW Dosch Road 1930.76 feet more or less to a point; thence around the arc of a curve to the left, the radius of which is 73.3 feet to a point which is tangent to the south line of SW Dosch Road; thence easterly tracing the south line of SW Dosch Road, and its easterly extension, to a point in the west boundary line of the City of Portland; thence tracing the city boundary line north and continuing along the said boundary line to the point of beginning.

ANNEXATION PROPOSITION NO. 2.

Beginning of the point of intersection of the vest line of SW 35th Avenue and the south line of SW Vermont Street; thence westerly tracing the southerly line of St. Vermont Street to its intersection with the southerly projection of the westerly line of Vermont Hills; thence northerly tracing the westerly line of Vermont Hills and its southerly extension to a point in the southeasterly line of Si Shattuck Road; thence northeasterly along the easterly line of SW Shattuck Road to its intersection with the north line of the South 1/2 of the South 1/2 of Section 18, T. 1 S. R. 1 E. W. M.; thence east tracing the north line of the South 1/2 of the South 1/2 of said Section 18 to the southeast corner of the SV 1/4 of the NE 1/4 of the SE 1/4 of Section 13; thence north tracing the east line of the SW 1/4 of NE 1/4 of SE 1/4 of said Section 18 to a point which is 154.07 feet south of the NE corner of the SV 1/4 of NE 1/4 of SE 1/4 of Section 18; thence easterly to a point in the east line of the NE 1/4 of the SE 1/4 of Section 13, which point is 154.27 feet south of the NE corner of the SE 1/4 of NE 1/4 of SE 1/4 of Section 18; thence continuing east on the projection of this last line to the east line of the SM 45th Avenue; thence south tracing the east line of Sid 45th Avenue to the north line of the SU 1/4 of Su 1/4, Section 17, T. 1 S., R. 1 E.; thence east tracing the north line of the S 1/2 of SW 1/4 of said Section 17 to the west line of SU 35th Avenue; thence southerly tracing the westerly line of SU 35th Avenue to the point of beginning.

ANNEXATION PROPOSITION NO. 3.

Beginning at a point in the intersection of the south line of SW Vermont Street and the west line of SW 35th Avenue; thence northerly tracing the westerly line of SW 35th Avenue to the northerly line of SW Cullen Boulevard; then southeasterly along the northerly line of SW Cullen Boulevard to the westerly line of the SE 1/4 of Section 17, T. 1 S., R. 1 E., W. M.; thence northerly tracing said 1/4 section line to the NW corner of the SW 1/4 of the SW 1/4 of the NE 1/4 of said Section 17; thence easterly along the northerly line of the SW 1/4 of the SW 1/4 of the NE 1/4 of said Section 17 to the westerly line of SU Dosch Road; thence southeasterly and easterly tracing the south line of SW Dosch Road and its easterly extension to the Portland city boundary; thence southerly, easterly, and southerly, tracing the city boundary line and its southerly extension to the south line of S^V Vermont Street; thence westerly along the south line of S^W Vermont Street to the point of beginning.

ANMEXATION PROPOSITION NO. 8

Beginning at the point of intersection of the eastern boundary line of the City of Portland and the north line of SE Washington Street, as now laid out; thence easterly tracing the northerly line of SE Washington Street, and its extension easterly, to the westerly line of SE 96th Avenue; thence southerly tracing the westerly line of SE 96th Avenue to the southerly line of SE Salmon Street; thence westerly tracing the southerly line of SE Salmon Street to the east boundary line of the city of Portland; thence northerly tracing the east city boundary line to the point of beginning, in Section 4, T. 1 S., R. 2 E., W. M.

hereby are and by virtue of said elections were and are annexed to the City of Portland, and the description of the boundaries of said city contained in the charter thereof by virtue of such election is changed to include the above described territory therein.

Section 2. It appearing to the Council that 100% of the owners of property in areas in this section described petitioned the City of Portland, in petitions dated October 7, 1949 and November 7, 1949, filed in the office of the Auditor of the City of Portland on November 1, 1949 and November 8, 1949, respectively, and in a petition dated April 12, 1950, filed in the office of the Auditor of the City of Portland on April 13, 1950, for annexation of such areas to the City of Portland, and pursuant to such petitions, and pursuant to Ordinances No. 91212 and 91514, of the City of Portland, passed February 16, 1950 and April 20, 1950, respectively, an election was held within the City of Portland on May 19, 1950, in the manner prescribed by law, to determine the question of whether such areas should become annexed to said city, and it appearing that in such election, a majority of voters of the City of Portland, voting as shown by the official canvass thereof, voted favorably upon the question of the annexation of such areas to the City of Portland, and it appearin that all of the procedure required by Chapter 210, Oregon Laws 1949 was complied with in such annexation proceedings; now, therefore, said areas described and designated on the ballot as:

ANNEXATION PROPOSITION NO. 9.

Beginning at the point of intersection of the west line of SW Dertha Boulevard and the Portland city boundary; thence southeasterly tracing the west line of SW Bertha Boulevard to the northerly line of SW Miles Street; thence southwesterly, tracing the northerly line of SW Miles Street to the point of intersection with the northwesterly extension of the line on the northeasterly side of Lot 1, Block 20, Capitol Hill in Section 21, T. 1 S., R.1E., W.M., thence southeasterly along the northeasterly line of Lots 1 and 15 in said Block 20, to the most easterly corner of said Lot 15; thence southwesterly along the southerly line of said Lot 15 to its most southerly corner; thence southeaster-ly along the easterly line of Lots 7 to 14, inclusive, in said Block 20, to a point in the north line of SW Custer Street; thence east tracing the north line of SW Custer Street to a point in the Portland city boundary; thence northerly and westerly tracing the city boundary line, to the point of beginning, and

ANNEXATION PROPOSITION NO. 10.

Lots 1 to 16, inclusive, and Lot A, Block 7, Sandberg Addition, as shown by the official map and plat thereof on file in the office of the Clerk of Multnomah County, State of Oregon

hereby are and by virtue of said petitions and election were and are annexed to the City of Portland and the description of the boundaries of the city contained in the charter thereof, by virtue of said petitions and election, is changed to include the above described areas therein.

Section 3. The Auditor of the City of Portland hereby is directed and authorized to forthwith make and transmit to the Secretary of State of the State of Oregon a certified description of the above described annexed areas to the City of Portland, an abstract of such annexation vote as shall show the whole number of electors voting in the areas described in Section 1 hereof, the whole number of electors voting in the City of Portland upon the question of annexation of the areas described in Section 1 hereof. the whole number of electors voting in the City of Portland upon the question of annexing the areas described in Section 2 hereof, the number of votes cast in each for each annexation respectively, the number of votes cast in each accinst each annexation respectively, a certified copy of the aforesaid petitions from 100% of the property owners in the areas described in Section 2 hereof, and certified copies of the material documents showing the procedure followed in calling such election and declaring the results thereof, all in compliance with Chapter 210, Oregon Laws 1949. From and after the date of filing of such abstract by the Auditor with the Secretary of State, the annexation of each of such areas shall be deemed complete and purguant to Chapter 210, Oregon Laws 1949, such date shall be considered the effective date of and nexation of each of such areas to the City of Portland. The Auditor of the City of Portland is further authorized and directed to file official notices of such annexations with the Clerk and Assessor of Multnomah County, respectively, pursuant to law and to pive such other notices concerning said annexation as are required by the laws of the State of Oregon.

Section 4. Inasmuch as this ordinance is necessary for the immediate preservation of the public health, peace, and safety of the City of Portland in this: That the annexation of such areas should be effected as quickly as possible in order that the will of the voters may be immediately put into effect and confusion concerning the effective date of such annexations shall be clarified; therefore, an emergency hereby is declared to exist and
