

ORDINANCE No. 91875

An Ordinance accepting for sewer purposes, an easement granted by Russell D. Ward and Viretta W. Ward, husband and wife, and declaring an emergency.

The City of Portland does ordain as follows:

Section 1. That the following described easement be and is hereby accepted for the S.W. Sunset Boulevard and S. W. Dosch Road Sewer System.

A strip of land 5.0 feet in width, being 2.5 feet on each side of the following described center line:

Beginning at a point in the west line of S.W. Cheltenham Street 2.5 feet south of the south line of Block 5, Hillsdale Heights, as now laid out; thence westerly, 2.5 feet southerly of and parallel to the south line of said Block 5, a distance of 330 feet, more or less, to a point in the east line of Block 3, Hillsdale Heights, in the City of Portland, County of Multnomah and State of Oregon. (Granted by Russell D. Ward and Viretta W. Ward, 1731 W.E. 45th Ave., \$190.00 being the amount to be paid for said easement.)

Section 2. That the City Auditor be and he is hereby directed to have the easement, for sewer purposes, as described in Section 1 of this ordinance, placed on record and a copy of said ordinance forwarded to the County Assessor.

Section 3. Inasmuch as this ordinance is necessary for the immediate preservation of the public health, peace, and safety of the City of Portland in this; To avoid any unnecessary delay in the construction of this proposed sewer; therefore, an emergency is hereby declared to exist and this ordinance shall be in force and effect from and after its passage by the Council.
