## ORDINANCE No. 187633

\*Authorize Amended Consortium Agreement with Multnomah and Washington Counties under the Workforce Investment Act of 1998 for career placement and training services (Ordinance)

The City of Portland ordains:

## Section 1. The Council finds:

- 1. There are serious and complex problems resulting from unemployment and low wages among residents in the region; and
- 2. Workforce development problems and solutions transcend traditional governmental boundaries; and
- 3. The City of Portland, Multnomah County and Washington County have been designated by the Governor as a local Workforce Investment Area ("Area") for the purposes of the Workforce Innovation and Opportunity Act of 2014 ("WIOA").
- 4. The WIOA requires that public entities in a multi-jurisdictional Area enter into consortium agreements.
- 5. By Ordinance 179944, adopted February 22, 2006 the Portland City Council approved a Consortium Agreement between the City of Portland, Multnomah County and Washington County pursuant to the requirements of the Workforce Investment Act of 1998.
- 6. Worksystems Inc. ("WSI") currently serves as the grant recipient and fiscal agent for the Area, and as such, funds career placement and training services in the City of Portland, Multnomah and Washington Counties and will continue to serve this function under the Amended Consortium Agreement.
- 7. Like the Consortium Agreement previously approved by the Council, the Amended Consortium Agreement provides for broad-based representation from the community (including significant representation from the private business sector and labor organizations) on the Workforce Development Board ("WDB") that governs Worksystems, Inc.
- 8. The Amended Consortium Agreement updates terms and references; extends the plan content from 2 to 4 years; extends the term of the Board Chair to 2 years; and revises the Board composition to comply with WIOA.

## NOW, THERFORE, the Council directs:

a. The Mayor is authorized to sign the attached Amended Consortium Agreement, substantially in accordance with the original of this ordinance and, by reference, made a part hereof.

- b. The Mayor is authorized to take all actions on behalf of the City of Portland under the Agreement.
- The Mayor is appointed to the Workforce Development Board as the City's designee. c.

The Council declares that an emergency exists because a delay in executing the Agreement could delay the development and implementation of area's Regional Workforce Strategic Plan; therefore, this ordinance shall be in full force and effect from and after its passage by the Council.
