

ORDINANCE NO. 187643

* Authorize disposal of surplus firearms property and authorize an Intergovernmental Agreement with the Washington County Sheriff's Office for the Portland Police Bureau to proceed with sale of the property (Ordinance)

The City of Portland ordains:

Section 1. The Council finds:

1. The Police Bureau has and wishes to dispose of six surplus MP5 firearms.
2. The Washington County Sheriff's Office (WCSO) requests to purchase the six surplus firearms for \$850 each to expand their inventory of MP5s for their uniform road deputies.
3. The City and WCSO wish to enter into an intergovernmental agreement that outlines responsibilities and limits City liabilities.
4. The MP5s have been declared surplus by the Commissioner for the Portland Police Bureau, Mayor Hales, in a memorandum dated January 25, 2016.
5. City Code 5.36, Disposition of Surplus Property, authorizes disposal of surplus property.
6. Specific to Subsection 5.36.010 F, Exempt Property, Council approval is required for the disposal of firearms.
7. Council declares that it is in the interest of the City and the WCSO to effect this transaction as soon as possible so that the WCSO may receive this surplus property without delay.

NOW, THEREFORE, the Council directs:

- a. That the Mayor is authorized to execute an agreement between the City and the Washington County Sheriff's Office as outlined in a form similar to the contract attached as Exhibit A.

- b. The City's Project Manager is authorized to execute amendments to the scope of services or the terms and conditions of this Agreement, provided the changes do not increase the amount of compensation or increase the City's financial risk.

Section 2. The Council declares that an emergency exists as it is important for the benefit of the WCSO and the City to effect a complete removal of the surplus property and to determine the final disposition without additional delay; therefore, this ordinance shall be in full force and effect from and after its passage by the Council.
