ORDINANCE No. 93816

An Ordinance accepting a sewer easement through Lot 7, Block 1, The White Tract, granted by Gustaf Wilde, a widower, for sewer purposes, and declaring an emergency.

The City of Portland does ordain as follows:

Section 1. That the following described easement granted for a sewer in private property between N.W. 25th Avenue and N.W. 25th Place, north of N.W. Nicolai Street, be and is hereby accepted for sewer purposes:

A portion of Lot 7, Block 1, The White Tract, being a strip of land 5 feet in width, 2.5 feet on either side of the following described center line:

Beginning at a point in the northeasterly line of Lot 7, Block 1, The White Tract, 2.5 feet southeasterly of the most northerly corner of said Lot 7; thence southwesterly, parallel to and 2.5 feet distant from the northwesterly line of said Lot 7 to a point in the southwesterly line of said Lot 7, being in the corporate limits of the City of Portland, County of Multnoman and State of Oregon.

(Granted by Gustaf Wilds, a widower, 2616 N.W. 25th Place.)

Section 2. That the City Auditor be and he is hereby directed to have this easement, as described in Section 1 of this ordinance, placed on record, and a copy of said ordinance forwarded to the County Assessor.

Section 3. Inasmuch as this ordinance is necessary for the immediate preservation of the public health, peace and safety of the City of Portland in this: To avoid any unnecessary delay in making this right-of-way a matter of record; therefore an emergency is hereby declared to exist, and this ordinance shall be in force and effect from and after its passage by the Council.
