

ORDINANCE No. 95915

An Ordinance accepting a sewer easement through a portion of Lot 16, Block 1, Hillsdale Heights, granted by Bosco Bisaccio and Valeria J. Bisaccio, husband and wife, for the S.W. Sunset Boulevard and S.W. Dosch Road Sewer System, and declaring an emergency.

The City of Portland does ordain as follows:

Section 1. That the following described easement and consent to sewer easement granted for the S.W. Sunset Boulevard and S.W. Dosch Road Sewer System be and are hereby accepted for sewer purposes:

A portion of Lot 16, Block 1, Hillsdale Heights, being a strip of land 5.0 feet in width, 2.5 feet on either side of the following described center line:

Beginning at a point in the northwesterly line of Lot 16, Block 1, Hillsdale Heights, 157.80 feet southwesterly of the northeasterly corner of said Lot 16; thence southwesterly in a straight line to a point in the southeasterly line of said Lot 16, 174.00 feet southwesterly of the southeasterly corner of said Lot 16, situate in the corporate limits of the City of Portland, County of Multnomah and State of Oregon. (Granted by Bosco Bisaccio et ux, 1626 S.W. Sunset Blvd., \$38.50 being the amount to be paid for said easement.)

Section 2. That the City Auditor be and he is hereby directed to have this easement, as described in Section 1 of this ordinance, and the consent to sewer easement, placed on record, and a copy of said ordinance forwarded to the County Assessor.

Section 3. Inasmuch as this ordinance is necessary for the immediate preservation of the public health, peace and safety of the City of Portland in this: To avoid any unnecessary delay in making this right-of-way a matter of record; therefore an emergency is hereby declared to exist, and this ordinance shall be in force and effect from and after its passage by the Council.
