## ORDINANCE No. 98426

An Ordinance accepting a sever easement through Tax Lot 9, Section 20, T. 1 S., R. 1 E., W.M., granted by Wayne Robert Miller and Florence Irane Miller, for the S.W. Multnomah Soulevard Storm and Sanitary Trunk Sever Systems, and declaring an emergency.

The City of Portland does ordain as follows:

Section 1. That the following described easement granted for the S.W. Multnomen Boulevard Storm and Samitary Trunk Sewer Systems be and is hereby accepted for sever purposes:

The south 10 feet of the west 161 feet of that certain tract of land conveyed to Wayne Robert Miller and Florence Ireme Miller, husband and wife, by deed recorded in Book 1230 at Page 206, Multnomen County P.S. deed records for 1947, and known as Tax Lot 9, Section 20, T. 1 S., R. 1 E., W.M., being within the corporate limits of the City of Portland, County of Multnomen and State of Oregon.

(Granted by Wayne Robert Miller and wife, 7330 S.W. 53rd Avenue, \$80.50 being the amount to be paid for said easement.)

Section 2. That the City Auditor be and he is hereby directed to have this essement, as described in Section 1 of this ordinance, placed on record and a copy of said ordinance forwarded to the County Assessor.

Inamuch as this ordinance is necessary for the immediate preservation of the public health, peace and selety of the City of Portland in this: To avoid any delay in making this right-of-way a matter of records therefore an emergency is hereby declared to exist and this ordinance shall be in force and effect from and after its passage by the Council.
