## ORDINANCE No. 99361

JUSST

An Ordinance accepting certain property deeded by The Port of Portland, a municipal corporation, for street purposes on Swan Island, and declaring an emergency.

The City of Portland does ordain as follows:

Section 1. That the following described parcel of property be and is hereby accepted for street purposes:

A parcel of land in Section 21, Township 1 North, Range 1 East, Willamette Meridian, Multnomah County, Oregon, described as follows:

Beginning at the center of said Section 21, running thence North 0 02' 30" E., 198 feet to the center line of N. Going Street; thence North 89 53' West along the center line of said street 1410.46 feet to a point, said point being the southwest corner of N. Basin Avenue, dedicated and accepted by the Council of the City of Portland by Ordinance No. 95994, March 13, 1952, and the true point of beginning; thence North 89 53' West, 265.44 feet, to an angle point in the Harbor Line, Willamette Hiver; thence North 73 °54' 30" West, 297.70 feet; thence North 5° 38' 40" East, 80 feet to a point on the southerly boundary of a tract of land under lease by The Port of Portland to the United States of America; thence along said boundary: S. 52° 15' East, 17.78 feet; thence S. 81° 07' East, 456.10 feet; thence along a curve to the left, having a radius of 38.38 feet and a central angle of 61° 25' 55", 41.15 feet to a point on the westerly right of way line of N. Basin Avenue; thence S. 23 56' East along said right of way live, 104.91 feet to the point of beginning. ALSO, a strip of land, 80 feet wide, in said Sections 20 and 21, the easterly boundary of which is contiguous with the westerly boundary of the above described tract, the center line of which is described as follows: beginning at a point 2,328.75 feet south of and 666.46 feet east of thenorth-west corner of said Section 21; thence H. 84° 21' 20" West, 1120.99 feet; thence along a curve to the right, having a radius of 2865 feet and a central angle of 31° 47' 50", a distance of 1589.85 feet; thence N. 52° 33' 39" west 2501.25 feet to the terminal point, which point is 3895.86 feet West of and 121.39 feet south of the northeast corner of said Section 20.

Inasanch as this ordinance is necessary for the immediate preservation of the public health, peace and safety of the City of Fortland in this: To avoid any unnecessary delay in the recording of this deed; therefore, an emergency is hereby declared to exist and this ordinance shall be in force and effect from and after its passage by the Council.
