ORDINANCE No. 99729

An Ordinance authorizing the Mayor and Auditor to draw a warrant on the General Fund in favor of John D. Goss, 3800 N. E. Sandy Boulevard, covering overcharge refund on building permit fee, and declaring an emergency.

The City of Portland does ordain as follows:

Section 1. The Council finds that building permits Number 339506 and 339507 were issued to John D. Goss, 3800 N. E. Sandy Boulevard, on November 24, 1953, to construct a new motor hotel on Lots 1 to 9 less East 50' of 1,2, and 3, Block 6, Rossmere Addition, and Lot 5, part of 4, Block 12, Hancock Street Addition, for which a fee of \$359.50 was received. The Council further finds that John D. Goss. through an error on the part of the Bureau of Buildings, was overcharged a fee of \$10.00 for these permits and that the fee for permit Number 339506 and 339507 should have been \$349.50 instead of \$359.50 and John D. Goss is now asking for a refund of \$10.00 overcharged on these permits, and payment of this fee is evidenced by City Treasurer's receipt No. 53296, and a refund is approved by the Commissioner of Finance, now, therefore, the Mayor and Auditor be and they are hereby authorized to draw a warrant in favor of John D. Goss, 3800 N. E. Sandy Boulevard, in the amount of \$10.00, which warrant shall be made chargeable to the General Fund Appropriation refund 4700.

Section 2. Inasmuch as this ordinance is necessary for the immediate preservation of the public health, peace, and safety of the City of Portland in this: that no undue delay should be occasioned in the settlement of refunds such as the above; therefore, an emergency is hereby declared to exist and this ordinance shall be in force and effect from and after its passage by the Council.
