ORDINANCE No. 101308

An Ordinance accepting certain property deeded by Porest Investment Company for the opening and extension of N. Reson Street between N. Basin Avenue and the westerly line of the Union Pacific Railway Company right-of-way, and declaring an emergency.

The City of Portland does ordain as follows:

Section 1. That the following described parcel of property be and is hereby accepted for street purposes:

"A strip of land 60 feet in width in Sections 20 and 21, TlW, RlE, W.M., more fully described as follows:

Beginning at a point in the east line of N.
Basin Avenue, as now laid out 216 feet south
of the north line of Section 20, TlN, RlE,
W.H. when measured at right angles thereto;
thence N 89° 45' E parallel to the north line
of said Section 20 and 21 a distance of 1183.4
feet; thence easterly and southerly 225.54 feet
around the arc of a 50 foot radius curve to the
right, the central angle of which is 258° 27'
and the long shord bears S 38° 58' 30" W 77.47
feet to a point which is 276 feet south of the
north line of Section 21 when measured at right
angles thereto; thence S 89° 45' W 1057.6 feet,
more or less, to the east line of N. Basin Avenue;
thence N 52° 15' W 97.46 feet along the casterly
line of N. Basin Avenue to the point of beginning."

(Deeded by Forest Investment Co. 715 S.W. Columbia Street.)

Section 2. That the City Auditor be and he is hereby directed to have the deed for atreet purposes as described in Section 1 of this ordinance placed on record and a copy of said ordinance forwarded to the County Assessor.

Section 3. Inasmuch as this ordinance is necessary for the immediate preservation of the public health, peace, and mafety of the City of Portland in this: To avoid any

unnecessary delay in the opening and extension of this street; therefore, an emergency is hereby declared to exist and this ordinance shall be in force and effect from and after its passage by the Council.
