This contract is between the City of Portland ("City," or "Bureau") and Morrison Child and Family Services, hereafter called Consultant. The City's Project Manager for this contract is Lisa Hansell.

#### **Effective Date and Duration**

This contract shall become effective on March 1, 2016. This contract shall expire, unless otherwise terminated or extended, on June 30, 2017.

#### Consideration

- (a) City agrees to pay Consultant a sum not to exceed \$146,062 (one hundred and forty six thousand and sixty two dollars) for accomplishment of the work.
- (b) Interim payments shall be made to Consultant according to the schedule identified in the STATEMENT OF THE WORK AND PAYMENT SCHEDULE.

# TERMS AND CONDITIONS

#### 1. Standard of Care

Consultant shall perform all services under this contract using that care, skill, and diligence that would ordinarily be used by similar professionals in this community in similar circumstances.

# 2. Effect of Expiration

Passage of the contract expiration date shall not extinguish, prejudice, or limit either party's right to enforce this Contract with respect to any default or defect in performance that has not been corrected.

#### 3. Order of Precedence

This contract consists of these Terms and Conditions, the Statement of Work and Payment Schedule, and any exhibits that are attached. Any apparent or alleged conflict between these items will be resolved by using the following order of precedence: a) these Terms and Conditions; b) Statement of Work and Payment Schedule; and c) any exhibits attached to the contract.

# 4. Early Termination of Contract

- (a) The City may terminate this Contract for convenience at any time for any reason deemed appropriate in its sole discretion. Termination is effective immediately upon notice of termination given by the City.
- (b) Either party may terminate this Contract in the event of a material breach by the other party that is not cured. Before termination is permitted, the party seeking termination shall give the other party written notice of the breach, its intent to

terminate, and fifteen (15) calendar days to cure the breach. If the breach is not cured within 15 days, the party seeking termination may terminate immediately by giving written notice that the Contract is terminated.

#### 5. Remedies and Payment on Early Termination

- (a) If the City terminates pursuant to 4(a) above, the City shall pay the Consultant for work performed in accordance with the Contract prior to the termination date. No other costs or loss of anticipated profits shall be paid.
- (b) If the City terminates pursuant to 4(b) above, the City is entitled all remedies available at law or equity. In addition, Consultant shall pay the City all damages, costs, and sums incurred by the City as a result of the breach.
- (c) If the Consultant justifiably terminates the contract pursuant to subsection 4(b), the Consultant's only remedy is payment for work prior to the termination. No other costs or loss of anticipated profits shall be paid.
- (d) If the City's termination under Section 4(b) was wrongful, the termination shall be automatically converted to one for convenience and the Consultant shall be paid as if the Contract was terminated under Section 4(a).
- (e) In the event of early termination the Consultant's work product before the date of termination becomes property of the City.

#### 6. Assignment

Consultant shall not subcontract, assign, or transfer any of the work scheduled under this agreement, without the prior written consent of the City. Notwithstanding City approval of a subconsultant, the Consultant shall remain obligated for full performance hereunder, and the City shall incur no obligation other than its obligations to the Consultant hereunder. The Consultant agrees that if subconsultants are employed in the performance of this Agreement, the Consultant and its subconsultants are subject to the requirements and sanctions of ORS Chapter 656, Workers' Compensation.

#### 7. Compliance with Applicable Law

Consultant shall comply with all applicable federal, state, and local laws and regulations. Consultant agrees it currently is in compliance with all tax laws. Consultant shall comply with Title VI of the Civil Rights Act of 1964 and its corresponding regulations. In connection with its activities under this Contract, the Consultant shall comply with all applicable Grant Terms and conditions. This includes all terms and conditions contained in this contract and, for a contract involving a grant, the Grant Terms and Conditions.

#### 8. Indemnification for Property Damage and Personal Injury

Consultant shall indemnify, defend, and hold harmless the City, its officers, agents, and employees, from all claims, losses, damages, and costs (including reasonable attorney fees) for personal injury and property damage arising out of the intentional or negligent acts or omissions of the Consultant, its Subconsultants, suppliers, employees or agents in the performance of its services. Nothing in this paragraph requires the Consultant or its insurer to indemnify the City for claims of personal injury or property damage caused by the negligence of the City. This duty shall survive the expiration or termination of this contract.

#### 9. Insurance

Consultant shall obtain and maintain in full force at Consultant expense, throughout the duration of the Contract and any warranty or extension periods, the required insurance identified below. The City reserves the right to require additional insurance coverage as required by statutory or legal changes to the maximum liability that may be imposed on Oregon cities during the term of the Contract.

Continuous Coverage; Notice of Cancellation: The Consultant agrees to maintain continuous, uninterrupted coverage for the duration of the Contract. There shall be no termination, cancellation, material change, potential exhaustion of aggregate limits or non renewal of coverage without thirty (30) days written notice from Consultant to the City. If the insurance is canceled or terminated prior to completion of the Contract, Consultant shall immediately notify the City and provide a new policy with the same terms. Any failure to comply with this clause shall constitute a material breach of Contract and shall be grounds for immediate termination of this Contract.

Additional Insured: The liability insurance coverages, except Professional Liability, Errors and Omissions, or Workers' Compensation, shall be without prejudice to coverage otherwise existing, and shall name the City of Portland and its bureaus/divisions, officers, agents and employees as Additional Insureds, with respect to the Consultant's activities to be performed, or products or services to be provided. Coverage shall be primary and non-contributory with any other insurance and self-insurance. Notwithstanding the naming of additional insureds, the insurance shall protect each additional insured in the same manner as though a separate policy had been issued to each, but nothing herein shall operate to increase the insurer's liability as set forth elsewhere in the policy beyond the amount or amounts for which the insurer would have been liable if only one person or interest had been named as insured.

Certificate(s) of Insurance: Consultant shall provide proof of insurance through acceptable certificate(s) of insurance, including additional insured endorsement form(s) and all other relevant endorsements, to the City prior to the award of the Contract if required by the procurement documents (e.g., request for proposal), or at execution of Contract and prior to any commencement of work or delivery of goods or services under the Contract. The Certificate(s) will specify all of the parties who are endorsed on the policy as Additional Insureds (or Loss Payees). Insurance coverages required under this Contract shall be obtained from insurance companies acceptable to the City of Portland. The Consultant shall pay for all deductibles and premium. The City reserves the right to require, at any time, complete, certified copies of required insurance policies, including endorsements evidencing the coverage the required.

Subconsultant(s): Consultant shall provide evidence that any subconsultant, if any, performing work or providing goods or service under the Contract has the same types and amounts of coverages as required herein or that the subconsultant is included under Consultant's policy.

# 10. Ownership of Work Product

All work product produced by the Consultant under this contract is the exclusive property of the City. "Work Product" includes, but is not limited to: research, reports, computer programs, manuals, drawings, recordings, photographs, artwork and any data or information in any form. The Consultant and the City intend that such Work Product shall be deemed "work made for hire" of which the City shall be deemed the author. If for any reason a Work Product is deemed not to be a "work made for hire," the Consultant hereby irrevocably assigns and transfers to the City all right, title and interest in such work product, whether arising from copyright, patent, trademark, trade secret, or any other state or federal intellectual property law or doctrines. Consultant shall obtain such interests and execute all documents necessary to fully vest such rights in the City. Consultant waives all rights relating to work product, including any rights arising under 17 USC 106A, or any other rights of authorship, identification or approval, restriction or limitation on use or subsequent modifications. If the Consultant is an architect, the Work Product is the property of the Consultant-Architect, and by execution of this contract, the Consultant-Architect grants the City an exclusive and irrevocable license to use that Work Product.

Notwithstanding the above, all pre-existing trademarks, services marks, patents, copyrights, trade secrets, and other proprietary rights of Consultant are and will remain the exclusive property of Consultant.

# 11. EEO Certification

In the event Consultant provides in excess of \$2,500.00 for services to the City in any fiscal year, Consultant shall obtain EEO certification from the City.

# 12. Equal Benefits

Consultant must comply with the City's Equal Benefits program as prescribed by Chapter 3.100 of the Code of the City of Portland. The required documentation must be filed with Procurement Services, City of Portland, prior to contract execution.

# 13. Successors in Interest

The provisions of this contract shall be binding upon and shall inure to the benefit of the parties hereto, and their respective successors and approved assigns.

# 14. Severability

The parties agree that if any term or provision of this contract is declared by a court of competent jurisdiction to be illegal or in conflict with any law, the validity of the remaining terms and provisions shall not be affected, and the rights and obligations of the parties shall be construed and enforced as if the contract did not contain the particular term or provision held to be invalid.

#### 15. Waiver

The failure of the City to enforce any provision of this contract shall not constitute a waiver by the City of that or any other provision.

#### 16. Errors

The Consultant shall promptly perform such additional services as may be necessary to correct errors in the services required by this contract without undue delays and without additional cost.

#### 17. Governing Law/Venue

The provisions of this contract shall be interpreted, construed and enforced in accordance with, and governed by, the laws of the State of Oregon without reference to its conflict of laws provisions that might otherwise require the application of the law of any other jurisdiction. Any action or suits involving any question arising under this contract must be brought in the appropriate court in Multnomah County Oregon.

# 18. Amendments

All changes to this contract, including changes to the scope of work and contract amount, must be made by written amendment and approved by the Chief Procurement Officer to be valid. Any amendment that increases the original contract amount by more than 25% must be approved by the City Council to be valid.

# 19. Business Tax Registration

The Consultant shall obtain a City of Portland business tax registration number as required by PCC 7.02 prior to beginning work under this Contract.

# 20. Prohibited Conduct

The Consultant shall not hire any City employee who evaluated the proposals or authorized the award of this Contract for two years after the date the contract was authorized without the express written permission of the City and provided the hiring is permitted by state law.

#### 21. Payment to Vendors and Subconsultants

The Consultant shall timely pay all subconsultants and suppliers providing services or goods for this Contract.

#### 22. Access to Records

The Consultant shall maintain all records relating to this Contract for three (3) years after final payment. The City may examine, audit and copy the Consultant's books, documents, papers, and records relating to this contract at any time during this period upon reasonable notice. Copies of these records shall be made available upon request. Payment for the reasonable cost of requested copies shall be made by the City.

# 23. Audits

- (a) The City may conduct financial and performance audits of the billings and services specified in this agreement at any time in the course of the agreement and during the three (3) year period established by paragraph 22. Audits will be conducted in accordance with generally accepted auditing standards as promulgated in <u>Government Auditing Standards</u> by the Comptroller General of the United States Government Accountability Office.
- (b) If an audit discloses that payments to the Consultant exceed the amount to which the Consultant was entitled, the Consultant shall repay the amount of the excess to the City.

# 24. Electronic Signatures

The City and Consultant may conduct this transaction, including any contract amendments, by electronic means, including the use of electronic signatures.

# 25. Merger Clause

This Contract encompasses the entire agreement of the parties, and supersedes all previous understandings and agreements between the parties, whether verbal or written.

# 26. Dispute Resolution/Work Regardless of Disputes

The parties shall participate in mediation to resolve disputes before conducting litigation. The mediation shall occur at a reasonable time after the conclusion of the Contract with a mediator jointly selected by the parties. Notwithstanding any dispute under this Contract, the Consultant shall continue to perform its work pending resolution of a dispute, and the City shall make payments as required by the Contract for undisputed portions of the work. In the event of litigation no attorney fees are recoverable. No different dispute resolution paragraph(s) in this contract or any attachment hereto shall supersede or take precedence over this provision.

#### 27. Progress Reports: /X/ Applicable / / Not Applicable

If applicable, the Consultant shall provide progress reports to the Project Manager as described in the Statement of the Work and Payment Schedule.

# 28. Consultant's Personnel: /X/ Applicable / / Not Applicable

If applicable, the Consultant shall assign the personnel listed in the Statement of the Work and Payment Schedule for the work required by the Contract and shall not change personnel without the prior written consent of the City, which shall not be unreasonably withheld.

# 29. Subconsultants

The Consultant shall use the subconsultants identified in its proposals. The Consultant shall not change subconsultant assignments without the prior written consent of the Chief Procurement Officer. The City will enforce all social equity contracting and Minority, Women and Emerging Small Business (M/W/ESB) subcontracting commitments submitted by the Consultant in its proposals. Failure to use the identified M/W/ESB subconsultants without prior written consent is a material breach of contract. For contracts valued \$50,000 or more, the Consultant shall submit a Monthly Subconsultant Payment and Utilization Report (MUR), made part of this contract by reference, reporting ALL subconsultants employed in the performance of this agreement. An electronic copy of the MUR may be obtained by contacting the PTE Contract Compliance Specialist.

# 30. Third Party Beneficiaries

There are no third party beneficiaries to this contract. Enforcement of this contract is reserved to the parties.

#### 31. Conflict of Interest

Consultant hereby certifies that, if applicable, its contract proposal is made in good faith without fraud, collusion or connection of any kind with any other proposer of the same request for proposals or other City procurement solicitation(s), that the Consultant as a proposer has competed solely on its own behalf without connection or obligation to, any undisclosed person or firm. Consultant certifies that it is not a City official/employee or a business with which a City official/employee is associated, and that to the best of its knowledge, Consultant, its employee(s), its officer(s) or its director(s) is not a City official/employee or a relative of any City official/employee who: i) has responsibility in making decisions or ability to influence decision-making on the contract or project to which this contract pertains; ii) has or will participate in evaluation or management of the contract; or iii) has or will have financial benefits in the contract. Consultant understands that should it elect to employ any former City official/employee during the term of the contract then that the former City official/Consultant employee must comply with applicable government ethics and conflicts of interest provisions in ORS Chapter 244, including but not limited to ORS 244.040(5) and ORS 244.047, and the City's Charter, Codes and administrative rules, including lobbying prohibitions under Portland City Code Section 2.12.080.

# 32. Respectful Workplace Behavior

The City of Portland is committed to a respectful work environment, free of harassment, discrimination and retaliation and other inappropriate conduct. Every individual has a right to work in a professional atmosphere where all individuals are treated with respect and dignity. The City's HR Rule 2.02 covers all employees with the City of Portland as well as consultants, vendors or consultants who provide services to the City of Portland. By signing this Contract/Agreement, the Consultant indicates compliance with all terms and conditions contained in this Contract including HR 2.02.

# STATEMENT OF THE WORK AND PAYMENT SCHEDULE

#### SCOPE OF WORK

Consultant shall provide culturally responsive and trauma-informed training, coaching and mental health consultation to non-profit corporations that provide early childhood, child abuse prevention and intervention, and foster care program services to children and their families.

Consultant shall perform the tasks listed below, and shall be expected to work closely with designated City personnel and City's training partners to accomplish these goals:

- 1. **Training** (April 2016 July 2016, or as needed through June 2017); forecasted number of direct training hours is 71; forecasted number of non-direct (e.g. preparation and travel) training hours is 1349.
  - Design and implement promotional materials and strategies to announce trainings to City's grantee programs providing Early Childhood, Child Abuse Prevention and Intervention, and Foster Care services.
  - b. Conduct an orientation for supervisors of City's grantee programs. The purpose of the training shall be to introduce the project framework and rationale for the package of trainings, coaching, and consultation designed to achieve staff development goals and to receive feedback from PCL grantees regarding training needs. It is estimated that a maximum of three 2-3 hour orientations will be provided.
  - c. Provide the EC-PBIS Strategies training series to City's grantee supervisors and direct service staff. The training shall present strategies for staff to use to promote social and emotional competencies within families. It shall also introduce the concepts of reflective practices and self-care. Additional topics covered in the series shall include: child brain development, brain function and trauma, family coaching, communication, and EC-PBIS strategies and supports. This comprehensive series shall include three sessions, 6 hours each. Additional 2-hour trainings, An Introduction to Developmental Stages and Parent-Child Attachment, shall be offered to programs needing further training. Content and material for each session shall be expanded and adapted to the age ranges and the populations served by City's grantees. It is estimated that a maximum of three 6 hour training sessions and a maximum of four 2 hour sessions will be provided.

- d. Provide the Trauma-Informed Strategies for Self-Care series to City's grantee supervisors and direct service staff. This series shall be comprised of six trainings of two hours each on a variety of topics designed to increase staff confidence and skills. Topics shall include, but are not limited to the following: Managing Compassion Fatigue; Strategies for Regulating Emotions; Impact of Change and Transition on Families and Staff; Understanding and Working with Diverse Temperaments; Using Observation with Staff/Families; Motivational Interviewing Skills; Reflective Practice for self-care; and Working with Diverse Thinking Styles. Content and material for each session shall be expanded and adapted to the age ranges and the populations served by City's grantees. It is estimated that a maximum of eighteen 2 hour sessions will be provided.
- e. The actual number of training sessions to be offered shall be dependent on demand for training. 6 hour trainings shall include a minimum of 25 attendees and maximum of 50 attendees. 2 hour trainings shall include a minimum of 15 attendees and maximum 25 attendees. Modifications to the training topics and number of trainings offered shall not be changed without the prior written consent of the City.
- f. Provide all materials and supplies necessary to deliver the training (e.g. training venue, training materials for participants, refreshments, audio-visual equipment).
- Offer continuing education hours through National Association of Social Workers and/or other organization approved by City.
- Communicate with City's grantee supervisors and direct service staff regarding the availability of each training activity and manage registration and other logistical details.
- Solicit feedback from the training participants at the end of each training activity. Use feedback to further refine and improve future training efforts.
- j. Submit copies of participant training materials, completed training feedback surveys, and a list of participants (including the names of participants, their organization and program affiliation, and email address) to City no more than 14 days after each training event.
- Non-direct training hours are limited to a maximum of 19 hours per direct hour of training.
- Provide a quarterly progress report of training services provided using the progress report template provided by City.
- 2. Coaching and Mental Health Consultation (April 2016 June 2017); forecasted number of direct coaching/consultation hours is 990 forecasted number of non-direct (e.g. preparation and travel) consultation hours is 863.
  - Develop overall strategy and plan to provide on-site coaching and consultation to grantees after training workshops end, and to support grantees implementing skills learned in trainings.
  - b. Solicit grantees to participate in optional on-site coaching/consultation. Develop an outreach and promotion strategy including program visits, phone calls, flyers, and/or follow-up surveys to assess interest in various consultation strategies.
  - c. Design and implement a planning tool or framework to help identify, in consultation with grantee program supervisor, areas of focus for on-site coaching; develop general work plan and schedule for on-site coaching that Consultant shall provide for each grantee that elects to participate in on-site coaching.
  - d. Provide individualized coaching and mental health consultation on-site to City's grantees, per developed workplan, that builds on topics covered in training activities; supports grantees to implement trauma-informed and culturally responsive reflective supervision, staff self-care practices, and EC-PBIS practices and approaches.
  - Written assessments and workplans for each City grantee opting to participate shall be submitted to City staff as they are developed.
  - f. Consultant shall encourage each site to develop a Leadership Team. The purpose of the team shall be to further integrate the learning goals into site culture, practices, and policy. A Leadership Team initially may be composed of a site Supervisor, identified staff, and the Consultant. This team shall use a Benchmarks of Quality format to track progress and plan further steps. Over time each site would be increasingly responsible for maintaining these practices with less consultation.
  - g. Meet regularly with City's training partners (Multnomah County Health Department Community Capacitation-Center, MCHD CCC and Portland State University Trauma-Informed Oregon, PSU TIO), convened by City staff, for site-case consultation and support with assuring on-site coaching is cultural responsive and trauma-informed.
  - h. Non-direct coaching and mental health consultation hours are limited to a maximum of 1 hour per direct hour of coaching/consultation.
  - Provide a quarterly progress report of coaching and mental health consultation services provided using the progress report template provided by City.
- 3. Coordination (March 2016 June 2017); forecasted number of coordination hours is 80.
  - a. Meet with designated City staff at least once every 8 weeks to review project implementation.
  - b. Participate, with other training partners and PCL staff, in the coordination of the three phases of the training plan to assure the entire thread of training is culturally responsive, has fidelity to trauma informed practice and care, and supports the development of program supervisors as well as direct service staff.
  - c. Provide feedback to City staff on other training, technical assistance, and consultation needs City's grantees may have.

# **COMPENSATION**

The maximum that the Consultant can be paid on this contract is \$146,062 (hereafter the "not to exceed" amount). The "not to exceed" amount includes all payments to be made pursuant to this contract, including reimbursable expenses, if any. Nothing in this contract requires the City to pay for work that does not meet the Standard of Care or other requirements of the Contract. The actual amount to be paid Consultant may be less than that amount.

The Consultant is entitled to receive progress payments for its work pursuant to the Contract as provided in more detail below. The City will pay Consultant based on these invoices for acceptable work performed and approved until the "not to exceed" amount is reached. Thereafter, Consultant must complete work based on the Contract without additional compensation unless there is a change to the scope of work.

Any estimate of the hours necessary to perform the work is not binding on the City. The Consultant remains responsible if the estimate proves to be incorrect. Exceeding the number of estimated hours of work does not impose any liability on the City for additional payment.

If work is completed before the "not to exceed" amount is reached, the Consultant's compensation will be based on the Consultant's bills previously submitted for acceptable work performed and approved.

# **PAYMENT TERMS: Net 30 Days**

# **Training**

The City will pay Contractor up to \$45.05 per approved individual who attends a 6-hour training.

# **Progress Payments**

On or before the 15<sup>th</sup> of each month, the Consultant shall submit to the City's Project Manager an invoice for work performed by the Consultant during the preceding month. The invoice shall contain the City's Contract Number and set out all items for payment including, but not limited to: the name of the individual, labor category, direct labor rate, hours worked during the period, and tasks performed. The Consultant shall also attach photocopies of claimed reimbursable expenses, if applicable. The Consultant shall stamp and approve all subconsultant invoices and note on the subconsultant invoice what they are approving as "billable" under the contract. The billing from the prime should clearly roll up labor and reimbursable costs for the prime and subconsultants – matching the subconsultant invoices. Prior to initial billing, the Consultant shall develop a billing format for approval by the City.

The City shall pay all amounts to which no dispute exists within 30 days of receipt of the invoice. Payment of any bill, however, does not preclude the City from later determining that an error in payment was made and from withholding the disputed sum from the next progress payment until the dispute is resolved.

The Consultant shall make full payment to its subconsultants within 10 business days following receipt of any payment made by the City to Consultant.

# **ACH Payments**

It is the City's policy to pay its Consultant invoices via electronic funds transfers through the automated clearing house (ACH) network. To initiate payment of invoices, Consultants shall execute the City's standard ACH Vendor Payment Authorization Agreement.

Upon verification of the data provided, the Payment Authorization Agreement will authorize the City to deposit payment for services rendered directly into Consultant accounts with financial institutions. All payments shall be in United States currency.
