



ORDINANCE No. 102331

An Ordinance accepting for street purposes certain portions of Lots 3, 4, and 5, Block 31, Love's Addition to the City of Portland, authorizing the drawing and delivery of a warrant upon certain terms and conditions, and declaring an emergency.

The City of Portland does ordain as follows:

Section 1. The Council finds that in connection with the widening of N. E. Columbia Boulevard between N. E. Hallory Avenue and N. E. Union Avenue, it is necessary to purchase a portion of Lots 3, 4 and 5, Block 31, Love's Addition to the City of Portland, from the owners thereof, Ernest M. Crystal and Evelyn R. Crystal; that the fair, just and equitable price for the required strip is \$200; that said strip should be acquired by the City only upon the condition that the residence now existing on the said Lot 5 be removed therefrom by the said Ernest M. and Evelyn R. Crystal; now, therefore, the following real property situated in the City of Portland, County of Multnomah, State of Oregon, hereby is accepted:

That portion of Lots 3, 4 and 5, Block 31, Love's Addition, lying northerly of a line that is southerly of and parallel to the center line of N. E. Columbia Boulevard (formerly County Road No. 97), and 50 feet distant therefrom when measured at right angles thereto.

Section 2. The Mayor and Auditor hereby are authorized to draw and deliver a warrant unto Ernest M. and Evelyn R. Crystal, husband and wife, the warrant to be chargeable against the general fund appropriation property for widenings and rights of way (4650.680).

Section 3. The said warrant is to be delivered upon the condition that the said Ernest M. and Evelyn R. Crystal covenant to the City of Portland to remove the residence building now existing on Lot 5, Block 31, Love's Addition within ninety (90) days from the passage of this ordinance, and said warrant shall, in no event, be delivered until the terms of this ordinance have been accepted by the said Ernest M. and Evelyn R. Crystal in form approved by the City Attorney.

Section 4. Inasmuch as this ordinance is necessary for the immediate safety of the City of Portland in this: in order that the required right of way for the widening of N. E. Columbia Boulevard may be obtained at the earliest possible date,

therefore, an emergency hereby is declared to exist, and this ordinance shall be force and effect from and after its passage by the Council.
