In the Matter of Accepting the Provisions of City of Portland Ordinance No. 102516, Passed by the Portland City Council August 4, 1955.

RESOLUTION

The above-entitled matter is before the Board of County Commissioners, and it appearing to the Board that heretofore Multnomah County, Oregon, petitioned the City of Portland for a permit to construct an addition approximately 28 feet by 90 feet to the second floor of the office and shop building on county-owned property at 2113 S. E. Morrison Street, Portland, Oregon; and

WHEREAS, in acting upon said petition the City of Portland enacted Ordinance No. 102516, which in words and figures and in part is as follows:

"Section 1. The Council finds that Multnemah County by the Board of County Commissioners, Jack Bain, M. James Gleason, and Al L. Brown, Commissioners, have petitioned the Council for a permit to construct an addition approximately 28' x 90' to the second floor of the office and shop building on county-owned property (Lone Fir Cemetery) at 2113 S. E. Morrison Street, authorized under Ordinance No. 96712 passed by the Council July 10, 1952, waiving the provisions of the Planning and Zoning Code of the City of Portland as this prop-erty is in Zone II and the Council further finds that the County finds it necessary to have this addition to the office building and that the Bureau of Buildings should be authorized to issue a permit for which application has been duly and regularly made and is approved by the Commissioner of Public Works: now, therefore, a revocable permit hereby is granted to Multnomah County by the Board of County Commissioners, Jack Bain, M. James Gleason, and Al L. Brown to construct an addition, approximately 28' x 90' to the second floor of the office and shop building, making a total of 90' x 159' in all at 2113 S. E. Morrison Street between S. E. 21 Avenue and S. E. 22 Avenue in Lone Fir Cemetery for use and benefit of the Road Department of the County and such other County offices or activities as are reasonably related to the said Road Department or the servicing of cemeteries under the control and jurisdiction of the County or like activity. The permit hereby granted does not run with the land and is personal to Multnomah County and may not be sold, conveyed or otherwise transferred and shall not be deemed a zone change, but is granted notwithstanding provisions of the Planning and Zoning Code of the City of Portland, Ordinance No. 77953, and particularly Section 6-607 thereof, and all provisions of the said Ordinance in conflict with this permit hereby are waived.";

and

WHEREAS, said ordinance requires the adoption and acceptance of the foregoing terms of said ordinance as a prerequisite to the issuence of a permit to proceed with the construction as hereinabove specified, and the Board being fully advised in the premises,

It is therefore ORDERED that each and all of the provisions of City of Portland Ordinance No. 102516 passed by the City Council of Portland, Oregon, on August 4, 1955, particularly described and

specified in Section 1 of said ordinance as hereinabove provided, be and the same are hereby accepted by Multnoman County, Oregon, as the terms and conditions under which the construction permit shall be issued by the Eureau of Buildings of the City of Portland; and

It is FURTHER ORDERED that Multnomah County, Oregon, shall make due application for a permit from the Bureau of Buildings of the City of Portland for authority to proceed with the construction work covered by said ordinance.

ORDINANCE No. 102516

An Ordinance granting a revocable permit to Multnomah county to construct an addition, approximately 28' x 90' to the second floor of the office and shop building on county-owned property (Lone Fir Cemetery) at 2113 S. E. Morrison Street authorized under Ordinance No. 96712 passed by the Council July 10, 1952, waiving the provisions of the Planning and Zoning Code, and declaring an emergency.

The City of Portland does ordain as follows:

Section 1. The Council finds that Multnomah County by the Board of County Commissioners, Jack Bain, M. James Gleason, and Al L. Brown, Commissioners, have petitioned the Council for a permit to construct an addition approximately 28' x 90' to the second floor of the office and shop building on county-owned property (Lone Fir Cemetery) at 2113 S. E. Morrison Street, authorized under Ordinance No. 96712 passed by the Council July 10, 1952, waiving the provisions of the Planning and Zoning Code of the City of Portland as this property is in Zone II and the Council further finds that the County finds it necessary to have this addition to the office building and that the Bureau of Buildings should be authorized to issue a permit for which application has been duly and regularly made and is approved by the Commissioner of Public Works; now, therefore, a revocable permit hereby is granted to Multnomah County by the Board of County Commissioners, Jack Bain, M. James Gleason, and Al L. Brown to construct an addition, approximately 28' x 90' to the second floor of the office and shopbuilding, making a total of 90' x 159' in all at 2113 S. E. Morrison Street between S. E. 21 Avenue and S. E. 22 Avenue in Lone Fir Cemetery for use and benefit of the Road Department of the County and such other county offices or activities as are reasonably related to the said Road Department or the servicing of cemeteries under the control and jurisdiction of the County or like activity. The permit hereby granted does not run with the land and is personal to Multnomah County and may not be sold, conveyed or otherwise transferred and shall not be deemed a zone change, but is granted notwithstanding provisions of the Planning and Zoning Code of the City of Portland, Ordinance No. 77953, and particularly Section 6-607 thereof, and all provisions of the said Ordinance in conflict with this permit hereby are waived.

Section 2. The Bureau of Buildings of the City of Portland hereby is authorized and directed to issue a permit upon the Board of County Commissioners by resolution, duly and regularly adopted accepting the provisions of this Ordinance, which resolution shall be approved by the City Attorney as to form and filed with the City Auditor, and, by accepting the terms and conditions of this Ordinance the County shall not be relieved from complying with all other applicable City codes and ordinances in connection with the building of said structure.

ORDINANCE No. 102516

Section 3. Inasmuch as this ordinance is necessary for the immediate preservation of the public health, peace and safety of the City of Portland in this: in order that there may be no delay in the County's taking advantage of favorable weather conditions for construction and completion of the building for early occupancy; therefore, an emergency hereby is declared to exist and this ordinance shall be in force and effect from and after its passage by the Council.
