## ORDINANCE No.

\*Authorize a contract with the lowest responsible bidder for the NE Prescott St: I-205 to NE 102<sup>nd</sup> Ave sidewalk project (Ordinance)

The City of Portland ordains:

Section 1. The Council finds:

- 1. There are several areas in east Portland where there are unsafe pedestrian connections to the surrounding neighborhoods which hinders pedestrian access to transit. The problems range from missing curb ramps and sidewalks to difficult and unsafe crossing locations of busy streets.
- 2. There is a missing section of sidewalk on NE Prescott St from I-205 to NE 102<sup>nd</sup> Avenue. The Portland Bureau of Transportation (PBOT) will complete this section of sidewalk including stormwater management. TriMet has been working with PBOT to include more bus frequency in East Portland if PBOT completes these missing links.
- 3. The Bureau of Transportation has funds budgeted in FY 2015-16 and proposed FY 2015-16 for construction, inspection and management of the project.
- 4. The Bureau's level of confidence in the cost estimate for this project is moderate as the project scope is clearly understood and well defined.

NOW, THEREFORE, the Council directs:

- a. Upon the Council's acceptance of the Chief Procurement Officer's report recommending the lowest responsible bidder, the Chief Procurement Officer is authorized to negotiate and execute a contract, provided the contract has been approved as to form by the City Attorney's office.
- b. The Auditor to draw and deliver warrants chargeable to PBOT T00504 when demand is presented and approved by the proper authority.

Section 2. The Council declares that an emergency exists because it is important to advertise this project as soon as possible to begin construction in the summer of 2016; therefore, this Ordinance shall be in full force and effect from and after its passage by the Council.
