SUBJECT: Accept Report on Rx Play Program Review and Evaluation (Report)

I am pleased to submit for your consideration and acceptance of the Rx Play Program Review and Evaluation Report. In 2009, the City of Portland Parks and Recreation Bureau (PP&R) and key partners formed the Portland RxPlay program, an innovative response to the childhood obesity epidemic that opens doors to physical activity opportunities by allowing healthcare providers to write patient prescriptions for recreation courses at P&R facilities. In December 2015, PP&R contracted with OPHI to conduct a high-level evaluation of the RxPlay program. The purpose of this report is to present and analyze data from the RxPlay program, evaluate current data and methodology, and make recommendations for future program and process improvements.
