

ORDINANCE No. 113217

An Ordinance officially naming as Delta Park the entire park area currently known as Vanport and East Vanport, and declaring an emergency.


The City of Portland does ordain as follows:

Section 1. The Council finds that there has been a growing interest in the recent acquisition and planned future development of the large tract of land currently known as Vanport; that this area is contiguous to the plot of land presently known as East Vanport and frequently referred to as Delta Park; that Vanport and East Vanport have not existed as such since May, 1948, and during their brief existence served only as temporary residential facilities during the emergency created by World War II; that in the proposed future development for the recreational and industrial use of said properties an official name should be given to the entire combined area; that the Commissioner in charge of the Bureau of Parks has recommended that the official name for the entire area be "Delta Park," and that for administrative purposes that area lying east of Denver Avenue should be referred to as East Delta Park, and that area lying west of Denver Avenue should be referred to as West Delta Park; now, therefore, the tracts of land currently known as Vanport and East Vanport, owned by the City and administered by the Bureau of Parks, shall be and the same hereby are officially named Delta Park, and for administrative purposes that area lying east of Denver Avenue shall be referred to as East Delta Park, and that area lying west of Denver Avenue shall be referred to as West Delta Park.


Section 2. Inasmuch as this ordinance is necessary for the immediate preservation of the public health, peace and safety of the city of Portland in this: in order that the official name of the tracts of land referred to in Section 1 hereof may be made a matter of record without delay, therefore, an emergency hereby is declared to exist and this ordinance shall be in force and effect from and after its passage by the Council.
