ORDINANCE No. 117616

An Ordinance transferring \$2,050 within the budget of the Bureau of Health for the purchase of a 3/4 ton van type vehicle, cancelling authority to purchase one sedan and declaring an emergency.

The City of Portland ordains:

Section 1. The Council finds that a 1951 Packard ambulance in the Bureau of Health is being used for transporting supplies and equipment; that it is impossible to secure parts for repair of said vehicle; that in the interest of economy and efficiency it should be replaced by a small van type vehicle; that two standard 6-cylinder, 4-door sedans are budgeted in the Meat Inspection Division of the Bureau of Health; and that authority for one of these sedans should be cancelled and the funds therefor transferred to the Main Office Division of the Bureau of Health for the purchase of a 3/4 ton van type vehicle; now, therefore, the sum of \$2,050 is hereby transferred within the General Fund, Appropriation Bureau of Health, from Meat Inspection Division, Equipment (948.720), to Main Office Division, Equipment (940.720), for the purchase of one 3/4 ton van type vehicle and the authority for one sedan in the budget of the Meat Inspection Division is hereby cancelled. The 1951 Packard ambulance, Inventory No. 55076 shall be transferred to the Bureau of Property Control for disposal after the van type vehicle authorized above has been purchased.

Section 2. Inasmuch as this ordinance is necessary for the immediate preservation of the public health, peace and safety of the City of Portland in this: In order that there may be no unnecessary delay in transferring authority and appropriation for the purchase of the van type vehicle for the Bureau of Health as described in Section 1 above; therefore, an emergency is hereby declared to exist, and this ordinance shall be in force and effect from and after its passage by the Council.
