

## ORDINANCE No. 118041

An Ordinance authorizing the Purchasing Agent to advertise and receive proposals for furnishing 10% D.D.T. solutions for the Bureau of Insect Control, authorizing a contract therefor for the calendar year 1964, authorizing the drawing and delivery of warrants, and declaring an emergency.


The City of Portland ordains:

Section 1. The Purchasing Agent hereby is authorized and directed to advertise and receive proposals for furnishing 10% D.D.T. solutions for the Bureau of Insect Control, Mosquito Control Division, Department of Public Safety, during the calendar year 1964, in accordance with the specifications therefor filed in the Bureau of Purchases January 24, 1964, which specifications hereby are adopted and by this reference made a part of this ordinance.

Section 2. The Mayor as Commissioner of Public Safety and the Auditor hereby are authorized and directed to enter into a contract with the lowest bidder submitting the most advantageous bid for the item mentioned in Section 1 hereof. The Council reserves the right to reject any and/or all bids, in whole or in part, and in the event no satisfactory bid is received, the Purchasing Agent hereby is authorized to readvertise therefor until a satisfactory bid is received. The Mayor and Auditor hereby are authorized and directed to draw and deliver warrants chargeable to the General Fund, Appropriation Bureau of Insect Control, Mosquito Control Division, Botanical & Agriculture (2560.210), when demand is presented, approved by the proper authorities.

Section 3. Inasmuch as this ordinance is necessary for the immediate preservation of the public health, peace and safety of the City of Portland in this: in order that the item mentioned in Section 1 hereof may be authorized without delay, therefore, an emergency hereby is declared to exist, and this ordinance shall be in force and effect from and after its passage by the Council.
