

## ORDINANCE NO. 118358

An Ordinance officially adopting names for certain parks and playgrounds in the City of Portland, and declaring an emergency.

The City of Portland ordains:

Section 1. The Council finds that there are a number of areas in the Portland Park System which have never been officially named although many have acquired names by popular usage; that it is in the public interest that parks have official names; now, therefore, parks and playgrounds as hereinafter recited and designated by number and location hereby are assigned names as follows:




