

## ORDINANCE No. 119035


An Ordinance repealing Ordinance No. 117306 which authorized condemnation proceedings for the acquisition of a tract of land in Section 9, T1S, R1E, W. M., for the Bureau of Water Works, and declaring an emergency.

The City of Portland ordains:


Section 1. The Council finds that Ordinance No. 117306, passed by the Council August 29, 1963, authorized commencement of condemnation proceedings to certain property therein described for the Bureau of Water Works; that in lieu of the property so described in said ordinance, the Bureau of Water Works did acquire other property, and such ordinance should be repealed; now, therefore, Ordinance No. 117306, passed by the Council August 29, 1963, entitled: "An Ordinance authorizing the City Attorney to commence and to prosecute to completion condemnation proceedings for the acquisition of a tract of land in Section 9, T1S, R1E, W.M., in the City of Portland, County of Multnomah, State of Oregon, for the Bureau of Water Works, as a tank storage site, authorizing expenditure not to exceed \$500, and declaring an emergency," hereby is repealed.

Section 2. Inasmuch as this ordinance is necessary for the immediate preservation of the public health, peace and safety of the City of Portland in this: In order that the records of the office of the City Auditor may be cleared without delay; therefore, an emergency hereby is declared to exist and this ordinance shall be in force and effect from and after its passage by the Council.
