ORDINANCE No. 121036

An Ordinance granting authority to the Bureau of Water Works to locate, construct and maintain a water reservoir in Washington Park, and declaring an emergency.

The City of Portland ordains:

Section 1. The Council finds that in order to meet the increasingly heavy demands of the present Southwest water supply system it is necessary to construct Sherwood Field Reservoir in Washington Park presently under the control of the Bureau of Parks; that location of the proposed reservoir has been agreed upon by the Bureau of Water Works and the Bureau of Parks; now, therefore, authority hereby is granted to the Bureau of Water Works to construct and perpetually maintain a water storage reservoir in Washington Park at the location hereinafter described:

Beginning at the S.W. corner of Lot 7, Block 5, ARDMORE in the N.W. 1/4 Section 4, T.1S., R.1E., W. M., Multnomah County, State of Oregon; thence South 18.00 feet; thence S. 40°41' W 251.70 feet; thence S 25°06' E 43.15 feet; thence S 21°40' W 71.35 feet; thence S 30°43' W 152.85 feet; thence S 22°33' W 256.11 feet; thence S 7°35' W 123.49 feet; thence S 78°11' W 250.00 feet; thence S 32°51' W 351.00 feet; thence S 19°00' E 262.30 feet; thence S 38°21' E 154.40 feet; thence S 23°03' E 215.79 feet; thence S 31°44' W 250.84 feet; thence S 64°40' W 59.50 feet; thence North 61°54' W 164.37 feet, to the center of a 52 foot diameter reservoir site, in the N. E. 1/4 of Section 5, T.1S., R.1E., W. M., all in the County of Multnomah, State of Oregon.

Section 2. Inasmuch as this ordinance is necessary for the immediate preservation of the public health, peace and safety of the City of Portland in this: In order that there be no unnecessary delay in construction of the necessary water service facilities for the City of Portland and for authority for use of park property for such purposes; therefore, an emergency hereby is declared to exist and this ordinance shall be in force and effect from and after its passage by the Council.
