

**ORDINANCE No. 187734**

\*Amend contract with CH2M Hill Engineers for additional work to complete the Smart Cities Challenge grant project and capacity for other project work in the amount of \$65,000 (Ordinance; amend Contract No. 31000660)

The City of Portland ordains:

Section 1. The Council finds:

1. In January 2016, the Portland Bureau of Transportation (PBOT) also engaged the services of CH2M to assist with the submission of Portland's Smart City Challenge grant due February 4, 2016.
2. Portland was selected as a finalist city for the grant on March 12, 2016 and received a grant of \$100,000 to be used to revise the grant application with the final application due May 24, 2016.
3. PBOT revised its contract with CH2M to assist with a large portion of the grant application to continue this work on the aggressive timeline.
4. In order to complete the Smart City work within the mandated timeframe, PBOT absorbed all the available capacity on this contract for the Smart City Challenge leaving no capacity for other ongoing work.
5. In order to complete the work for the Smart City Challenge grant and keep capacity available for other ongoing work, PBOT is seeking to amend the contract to provide for this budgeted and planned work.
6. PBOT has negotiated a contract amendment with CH2M for the work, with \$5,000 allocated to the remaining work on the Smart City Challenge and \$60,000 of capacity for completing any needed outstanding work items.
7. The Bureau's level of confidence in the cost estimates for this project is high because the amendment has been negotiated and adequate contingencies have been built into each task item.

NOW, THEREFORE, the Council directs:


- a. That the Commissioner-in-Charge is hereby authorized to execute the contract in a form similar to the contract attached as Exhibit A.

Section 2. The Council declares that an emergency exists because the work is continuing due to the time constraints of each process; therefore, this Ordinance shall be in full force and effect from and after its passage by the Council.


