

ORDINANCE No. 187746

*Change the salary grade for the Nonrepresented classification of City Treasurer and red-circle the incumbent's pay. (Ordinance)

The City of Portland ordains:

Section 1. The Council finds:

1. In accordance with the policies established by the City Council and based on a classification and compensation review, the Bureau of Human Resources is changing the salary grade for the Nonrepresented classification of City Treasurer, and red-circling the incumbent's pay, effective January 5, 2016.

NOW, THEREFORE, the Council directs:

- a. The following compensation rate is being changed:


