ORDINANCE No. 187751 As Amended

*Authorize settlement between Portland Police Association and the City of Portland through its Portland Police Bureau regarding employment claims (Ordinance).

The City of Portland ordains:

Section 1. The Council finds:

- 1. On August 2, 2013, the Portland Police Association ("PPA") filed PPA Grievance No. 2013-12 ("Sweeney Grievance"), alleging that the City had failed to pay Lonn C. Sweeney's lump sum sick leave into his VEBA upon retirement, consistent with Articles 26.5 and 65.2.3 of the PPA collective bargaining agreement ("CBA").
- 2. The City denied the Sweeney Grievance, which was then referred to arbitration. The primary issue in dispute was the definition of the term "retirement" and whether that meant, as the City alleged, direct retirement from City employment or, as the PPA alleged, retirement under the City's Fire Police Disability Retirement system ("FPDR").
- 3. On March 11, 2015, the PPA filed PPA Grievance No. 2015-03 ("Medical Separation/Layoff Grievance"), alleging that the City had unilaterally ended a past practice whereby PPA members received cash pay outs or VEBA contributions for accumulated sick leave upon medical separation or layoff, in violation of Article 3 (Existing Standards Clause) of the CBA.
- 4. The City denied the Medical Separation/Layoff Grievance, which the parties then tolled pending settlement discussions.
- 5. The parties now desire to compromise and settle these two grievances. A copy of the proposed Settlement Agreement is attached to this Ordinance as Exhibit A.
- 6. As part of the proposed settlement, the City shall deposit into Lonn C. Sweeney's VEBA account, on a pre-tax basis, the amount of \$37,145.22, which is the agreed upon amount that would have been deposited to Sweeney's VEBA account in accordance with Articles 26.5 and 65.2.3 of the CBA if Sweeney's retirement under FPDR met the requirements for payout of accrued but unused sick leave under the CBA.
- 7. Under the terms of the Settlement Agreement, effective January 1, 2016, and prospectively thereafter, for every PPA member who is medically separated from the Portland Police Bureau ("Police Bureau" or "PPB") as a result of a service connected injury or medical condition the City shall contribute to the PPA VEBA Trust, to the credit of that PPA member and on a pre-tax basis, an amount equal in value to 100% of the payments that would otherwise have been credited to that PPA member for accrued but unused sick leave under Articles 26.5 and 65.2.3 of the CBA.

- 8. Under the terms of the Settlement Agreement, PPA members who are separated from the Police Bureau for reasons other than a service connected injury or medical condition or retirement from the City are not eligible for payout of unused sick leave pursuant to the Settlement Agreement or otherwise under the CBA.
- 9. Under the terms of the Settlement Agreement, the PPA agrees to withdraw the Sweeney Grievance and the Medical Separation/Layoff Grievance with prejudice and not to file or prosecute any grievances for the cash out or credit of unused sick leave on behalf of any other PPA members who were medically separated from the Police Bureau prior to January 1, 2016.
- 10. PPB and the City Attorney's Office recommend acceptance of the proposed settlement.
- 11. Per PCC 3.15.050, the Director of the Bureau of Human Resources has reviewed and approved the proposed settlement.

NOW, THEREFORE, the Council directs:

- a. The Mayor, the Police Chief and the Director of the Bureau of Human Resources are authorized to enter into and execute the Settlement Agreement in the form attached to this Ordinance as Exhibit A, subject to approval as to form by the Office of the City Attorney.
- b. The Mayor and the Auditor are authorized to take all appropriate steps to effectuate the deposit into the PPA VEBA Trust, to the credit of the account of Lonn C. Sweeney, on a pre-tax basis, the amount of \$37,145.22.
- c. The Police Bureau shall execute a payment authorization in the amount set forth in sub-paragraph (b) above.

Section 2. The Council declares that an emergency exists in order to avoid undue and costly delay in settling this claim; therefore, this ordinance shall be in full force and effect from and after its passage by the Council.


