Don't be surprised when he/she pulls back your empty trash bins. As for MAS, when I heard Mrs. Santa Claus from on Peacock had moved into an **Assisted Living Facility**, I went to visit her. Apparently, there a federal regulations requiring facilities provide fresh fruit. Little

wonder when opening the bag of Hood River Bing Cherries, she said, "Apples! Oranges! Bananas!, so help me if I eat one more banana, I will grow a monkey's tail." For the next 19-months, my visits saved her \$8.00 in weekly fees, by simply putting clean laundry away. Every Saturday, I visited in my friend of 40-years, a retired Multnomah County employee. Unlike Mitch Albom's Tuesdays with Murray, I did not take notes... . Yet, I will treasure her stories... .

### **Older Americans living on Social Security fixed income... .**

My friend's Mother, lived 65 years in a Montavilla bungalow, at age 96. Her house was sold for \$206,000. She moved into a **Long-Term-Care-Facility** for \$8,000 a month, plus an \$8.00 fee point system. LTCF fees rising annually, within five years her "house money" was exhausted. Medicaid stepped in until she died at 103. Yes, she was sharp as a tack, and a joy to visit.

To be honest, the employees working in **Assisted Living Facility, Long-Term-Care-Facility** are simply too busy to visit. CNA are assisting patients with daily living skills, with bathing, dressing, spoon feeding, walking the halls, and/or dispensing medications. So if you have a passion for the rights of our elders, volunteering as a **Certified Ombudsman** will give you the opportunity to make a one-on-one difference. And for those of you too busy to "spend time" volunteering, you can help our elders by making donation one of the non-profits I mentioned earlier.

As for the Bully Grinch on Peacock Lane? Granted, Mayor Hales, Commissioner Dan Saltzman and/or Paul Allen do not live on Peacock Lane, and yes the Developer's will construct a show box between English Cottages "by right". This is a equity socioeconomic issue. Those who live on Peacock Lane lack resources to purchase the "in-fill-middle" sub-standard lot matching Vic Remmer's asking price: \$350,000. Again, and again, he has not been respectful of the culture, charm and character of Portland's older established neighborhoods, when holding Peacock Lane property owners hostage. When do Declaration of Restrictive Covenants come into play?

**DECLARATION OF  
RESTRICTIVE COVENANT**

THIS DECLARATION made this \_\_\_\_\_ day of \_\_\_\_\_, 2013,  
by \_\_\_\_\_ (“Declarant”).

**RECITALS**

1. WHEREAS, Declarant is the owner of the real property (“Property”) described in the attached Exhibit “A.”
2. WHEREAS the Property is part of the Eastmoreland Neighborhood, which, for purposes of this Declaration, includes all of the lots shown on the plats attached as Exhibits \_\_ through \_\_ (“Plats”);
3. WHEREAS, many of the lots in the Eastmoreland Neighborhood, were historically assembled, sold into one ownership and then developed with a single residence and grounds, as if they were one lot, and the resultant development pattern created a recognizable and desirable neighborhood identity;
4. WHEREAS, this neighborhood identity is threatened by the destruction of existing residences to provide an opportunity for denser development on lots that together formerly comprised a single ownership, and that, with the new residences, are then sold separately;
5. WHEREAS, Declarant wishes to restrict the separate sale of the lots that comprise the Property and to this end wishes to subject the Property to the covenants and restrictions hereinafter set forth;

NOW, THEREFORE, Declarant declares that the Property shall be held, transferred, sold, conveyed and occupied subject to the following covenants and restrictions, which shall run with the land, which shall be binding on all parties having or acquiring any right, title, or interest in the Property or any part thereof, and which shall inure to the benefit of each owner of the lots in the Eastmoreland Neighborhood, their successors and assigns; and to the benefit of the Eastmoreland Neighborhood Association, a domestic non-profit corporation, its successors and assigns.

**COVENANTS AND RESTRICTIONS**

1. The lots that comprise the Property, whether designated as “tax lots,” “lots of record,” “legal lots,” or by some other label, shall not be sold separately, but shall be maintained in one ownership.
2. The Property shall not be developed with more than one residence, a garage, and other accessory structures.
