ORDINANCE No. 187762

*Authorize Memorandum of Agreement with Multnomah County Drainage District for the 408 permit process to construct the Marine Drive Path around the Columbia River Levee (Ordinance)

The City of Portland ordains:

Section 1. The Council finds:

- The Portland Bureau of Parks and Recreation applied for a Congestion Mitigation and Air Quality (CMAQ) Grant in the amount of \$966,000 on September of 2011 for the Marine Drive Path: NE 112th Ave – 185th Ave Sec. project.
- 2. The Oregon Department of Transportation (ODOT) awarded the Portland Bureau of Transportation in the amount of \$966,000 for this project.
- 3. Multnomah County Drainage District (MCDD) operates and maintains levees and drainage facilities alongside the Columbia River which is adjacent to Marine Drive.
- 4. The project will require a drilling investigation into de Levee to install a new traffic signal and Portland Bureau of Transportation (PBOT) must obtain a permit from MCDD.
- 5. This Memorandum of Agreement will allow MCDD to charge PBOT for their services to review the permit for this project.

NOW, THEREFORE, the Council directs:

a. The Commissioner-in-Charge is hereby authorized to authorize to execute this agreement, approved as to form by the City Attorney, with Multnomah County Drainage District for the Marine Drive Path project, in a form similar to the contract attached as Exhibit A.

Section 2. The Council declares that an emergency exists because a delay would unnecessarily delay the City's ability to perform the activities authorized by the agreement; therefore, this ordinance shall be in full force and effect from and after its passage by the Council.


