ORDINANCE No. 125675

An Ordinance assigning to the use of the Bureau of Water Works Tract 11 and part of Tract 10, Willalatin Park Addition, located along N.W. Skyline Boulevard and declaring an emergency.

The City of Portland ordains:

Section 1. The Council finds that by authority of Ordinance No. 125205, passed by the Council August 17, 1967, certain real property consisting of Tracts 11, 12 15, 16, 19, 20, 23, 24, 27, 28 and the southeasterly one-half of Tract 7, Willalatin Park, was purchased by the City; that \$5000 of the \$34,600 total purchase price for such property was paid from the Water Construction Fund; that said Ordinance No. 125205 did not assign any part of the property thereby purchased to the Bureau of Water Works; that it was the intent of the Bureau of Water Works in contributing to the purchase of such property to be assigned certain parts of such property together with a part of Tract 10 adjoining Tract 11, Willalatin Park for Water Bureau purposes; that such assignment should now be made; now, therefore, there is hereby assigned to the Bureau of Water Works Tract 11 and the easterly 180.67 feet of Tract10, Willalatin Park Addition, Multnomah County, Oregon, for the uses of the Bureau of Water Works, and the Property Control Director is hereby authorized and directed to make the appropriate entries on the ownership books of the City to show such assignment.

Section 2. I_n as much as this ordinance is necessary for the immediate preservation of the public health, peace and safety of the City of Portland in this: In order that the property herein assigned to the Bureau of Water Works may be available for the purposes of such bureau without unnecessary delay; therefore, an emergency hereby is declared to exist and this ordinance shall be in force and effect from and after its passage by the Council.
