

## ORDINANCE NO. 127300

An Ordinance accepting a street deed for certain property in Section 14, T.1S., R.1E., W.M., granted by Drake Investment Co. for the opening of S. E. River Oaks Drive between S. E. Milwaukie Avenue near S. E. Mitchell Street and the south line of Lots 1, 2, 3 & 4, Block 16, P. J. Martin's Tract, and for the opening of S. E. Ellis Street between the westerly line of said S. E. River Oaks Drive and the easterly line of the Portland Traction Company right-of-way, and declaring an emergency.

The City of Portland ordains:

Section 1. That the following described property be and is hereby accepted for public street purposes:

A tract of land in the S. W. 1/4 Section 14, T.1S., R.1E., W.M., Multnomah County, Oregon, being more particularly described as follows:

Beginning at the point of intersection of the south line of the Edward Long D.L.C. with the southeasterly right-of-way line of the Portland Traction Company, thence N.  $89^{\circ} 56' 42''$  E. along said south line, a distance of 305.17 feet to the true point of beginning of the tract herein described; thence, from said true point of beginning N.  $22^{\circ} 58' 31''$  E. a distance of 385.22 feet to a point of curvature; thence along the arc of a 42.00-foot radius curve to the left, through a central angle of  $86^{\circ} 51' 28''$  (the long chord of which bears N.  $20^{\circ} 27' 13''$  W. 57.75 feet) an arc distance of 63.67 feet to a point of tangency; thence N.  $63^{\circ} 52' 57''$  W. a distance of 210.83 feet to the southeasterly right-of-way line of the Portland Traction Company aforesaid; thence N.  $26^{\circ} 07' 03''$  E. along said right-of-way line, a distance of 60.00 feet; thence, leaving said right-of-way line S.  $63^{\circ} 52' 57''$  E. a distance of 368.78 feet to a point of curvature; thence along the arc of a 100.00-foot radius curve to the left, through a central angle of  $88^{\circ} 05' 13''$  (the long chord of which bears N.  $72^{\circ} 04' 27''$  E. 139.04 feet) an arc distance of 153.74 feet to a point of tangency; thence N.  $28^{\circ} 01' 50''$  E. a distance of 378.06 feet to a point of curvature; thence along the arc of a 370.00-foot radius curve to the left, through a central angle of  $17^{\circ} 02' 50''$  (the long chord of which bears N.  $19^{\circ} 30' 25''$  E. 109.68 feet) an arc distance of 110.09 feet to a point of tangency; thence N.  $10^{\circ} 59' 00''$  E. a distance of 168.70 feet to a point of curvature; thence along the arc of a 353.00-foot radius curve to the left, through a central angle of  $43^{\circ} 29' 00''$  (the long chord of which bears N.  $10^{\circ} 45' 30''$  W. 261.52 feet) an arc distance of 267.90 feet to a point of reverse curvature; thence along the arc of a 98.00-foot radius curve to the right, through a central angle of  $87^{\circ} 36' 50''$  (the long chord of which bears N.  $11^{\circ} 18' 25''$  E. 135.68 feet) an arc distance of 149.86 feet to a point of reverse curvature; thence along the arc of a 75.00-foot radius curve to the left, through a central angle of  $65^{\circ} 26' 05''$  (the long chord of which bears N.  $22^{\circ} 23' 48''$  E. 81.07 feet) an arc distance of 85.65 feet to a point of tangency; thence N.  $10^{\circ} 19' 15''$  W. a distance of 150.00 feet to the westerly right-of-way line of S.E. Milwaukie Avenue; thence S.  $16^{\circ} 51' 00''$  E. along said right-of-way line a distance of 305.00 feet; thence leaving said right-of-way line on the arc of a 38.00-foot radius curve to the left, through a central angle of  $195^{\circ} 39' 00''$  (the long chord of which bears S.  $65^{\circ} 19' 30''$  W. 75.29 feet) an arc distance of 129.76 feet to a point of reverse curvature; thence along the arc of a 413.00-foot radius curve to the right, through a central angle of  $43^{\circ} 29' 00''$  (the long chord of which bears S.  $10^{\circ} 45' 30''$  E. 305.97 feet) an arc distance of 313.44 feet to a point of tangency; thence

S.  $10^{\circ}59'00''$  W. a distance of 168.70 feet to a point of curvature; thence along the arc of a 430.00-foot radius curve to the right, through a central angle of  $17^{\circ}02'50''$  (the long chord of which bears S.  $19^{\circ}30'25''$  W. 127.47 feet) an arc distance of 127.94 feet to a point of tangency; thence S.  $28^{\circ}01'50''$  W. a distance of 378.06 feet to a point of curvature; thence along the arc of a 160.00-foot radius curve to the right, through a central angle of  $88^{\circ}05'13''$  (the long chord of which bears S.  $72^{\circ}04'27''$  W. 222.46 feet) an arc distance of 245.99 feet to a point of tangency; thence N.  $63^{\circ}52'57''$  W. a distance of 13.74 feet to a point of curvature; thence along the arc of a 42.00-foot radius curve to the left, through a central angle of  $93^{\circ}08'32''$  (the long chord of which bears S.  $69^{\circ}32'47''$  W. 61.00 feet) an arc distance of 68.28 feet to a point of tangency; thence S.  $22^{\circ}58'31''$  W. a distance of 829.60 feet to the south line of Lots 2, 3, & 4, Block 16, P. J. Martin's Tract, a plat of record in said county; thence N.  $88^{\circ}54'00''$  W. along said south line a distance of 64.66 feet; thence, leaving said south line N.  $22^{\circ}58'31''$  E. a distance of 476.38 feet to the true point of beginning. (Granted by Drake Investment Co., 1740 N. W. Flanders Street, Portland, Oregon, c/o Williams, Montague, Stark & Thorpe, Attorneys and Counselors at Law, Failing Building, Portland, Oregon 97204).

Section 2. That the City Auditor be and he is hereby directed to have this street deed as described in Section 1 of this Ordinance placed on record, and a copy of said Ordinance forwarded to the Multnomah County Department of Finance.

Section 3. Inasmuch as this Ordinance is necessary for the immediate preservation of the public health, peace and safety of the City of Portland in this: To avoid any unnecessary delay in making this right of way a matter of record; therefore, an emergency is hereby declared to exist and this Ordinance shall be in force and effect from and after its passage by the Council.
