

## ORDINANCE No. 129211

An Ordinance accepting three water service easements for installation of water service vaults and pipelines on private property from Herbert M. Clark Jr. et ux and James Brink, et ux, Gilmore Steel Corporation and Consolidated Metco, Inc., and declaring an emergency.

The City of Portland ordains:


Section 1. The Council finds that the Bureau of Water Works has requested and obtained water main easements for the installation of water service vaults and pipelines on private property from Herbert M. Clark, et ux and James Brink, et ux, Gilmore Steel Corporation, through the Oregon Steel Mills Division, and Consolidated Metco, Inc, and said water main easements should be accepted by the City; now, therefore, the Auditor hereby is authorized and directed to accept and record the water main easements for Water Bureau purposes as follows:

1. An easement for a service vault at 4451 S.E. Johnson Creek Boulevard, executed by Herbert M. Clark Jr. and James Brink, a partnership, and Janet M. Clark and Bonnie Jean Brink, their wives-Drawing No.4-AJ-23.
2. An easement for a service vault and blow-off line at 1400 N. Rivergate Boulevard, executed by Gilmore Steel Corporation, drawing No. 4-AJ-25.
3. An easement for a service vault at 13940 N. Rivergate Boulevard, executed by Consolidated Metco, Inc., drawing No. 4-AJ-24.



Section 2.
