

ORDINANCE No. 187780

***Authorize an Intergovernmental Agreement with Portland State University for \$20,000 for Deep Carbon Reduction in the Transport Sector (Ordinance)**

The City of Portland ordains:

Section 1. The Council finds:

1. On July 21, 2015, the Urban Sustainability Directors Network (USDN)—a project of the Global Philanthropy Partnership (GPP) and to which the Bureau of Planning and Sustainability (BPS), City of Portland, is a member—applied to the Bullitt Foundation for a grant in the amount of \$75,000.
2. On October 7, 2015, The Bullitt Foundation notified the Global Philanthropy Partnership that it approved a grant in the amount of \$75,000 to 1) support cities of Portland, Seattle, and Vancouver, British Columbia, to participate in the Climate Neutral Cities Alliance (CNCA) and 2) to address issues of displacement and gentrification through research and policy development—the Portland Transit and Affordability Study.
3. Of the \$75,000 grant award, \$56,250 is dedicated to activities related to the Portland Transit and Affordability Study task of the grant proposal, Ordinance 187613.
4. The Portland Transit and Affordability Study will assess specifically the impacts of decarbonizing urban transportation on housing affordability, displacement, and carbon emissions in the Powell-Division transit corridor within the City of Portland.
5. Of the \$56,250 the City receives: \$20,000 will be passed on to Portland State University (PSU), under the direction of Lisa K. Bates, Ph.D., to carry out research on bus-rapid transit improvements and its impacts on housing affordability, displacement, and carbon emissions in the Powell-Division corridor. Funds are available in the Bureau of Planning and Sustainability FY 2015-16 Revised Budget, Grant ID PN000064, cost object PN00640001.

NOW, THEREFORE, the Council directs:

- a. The Mayor is hereby authorized to execute an intergovernmental grant agreement with Portland State University in a form substantially similar to the agreement attached as Exhibit 1.

- b. The Mayor and Auditor are hereby authorized to pay for the intergovernmental agreement chargeable to the Bureau of Planning and Sustainability, Cost Object PN00640001 when demand is presented and approved by the proper authority.
- c. The Director of the Bureau of Planning and Sustainability is hereby authorized to sign amendments for continuing data management, reporting and funding in future fiscal years if appropriations are approved by City Council.

Section 2. The Council declares that an emergency exists in order to forward funds for services to continue work that benefits the City. Therefore, this Ordinance shall be in full force and effect from and after its passage by the Council.


