An Ordinance amending provisions of Titles 16 of the Code of the City of Portland to correct errors therein.

The City of Portland ordains:

Section 1. The Council finds:

1. Ordinance No. 153799, effective October 11, 1982 amending Section 16.04.040(c) of the Code of the City of Portland contained a typographical error in that it was intended that said ordinance should have amended Section 16.04.050(c) of said Code and, accordingly, this ordinance has been incorrectly codified.
2. The City Code should be amended to correct these errors.

NOW, THEREFORE, The Council directs:

- a. Subsection 16.04.040(c) is hereby amended to read as follows:

(c)Written notice of the opportunity for a hearing to contest the validity of the towing of a vehicle shall be given by the towing company to each person who seeks to redeem a vehicle towed pursuant to this chapter.

- b. Subsection 16.04.050(c) is hereby amended to read as follows:

(c)The hearings officer shall set and conduct an administrative hearing on the matter within fourteen (14) days of receipt of a proper request filed pursuant to this section; provided however, that in all cases where a vehicle has been towed and not yet released at the time the request is filed, the hearings officer shall set and conduct the hearing within seventy-two (72) hours, not including Saturdays, Sundays, or holidays, of receipt of the request.
