

ORDINANCE No. 134689

An Ordinance amending Ordinance No. 134510, which authorized continuance of negotiations for purchase of Lot 8 and portions of Lots 4 and 5, Block K, Greenway, so as to set forth the amount of the purchase price in subsection a of Section 3 thereof, and declaring an emergency.

The City of Portland ordains:

Section 1. The Council finds that Ordinance No. 134510, passed by the Council May 10, 1972, authorized continuance of negotiations for purchase of Lot 8 and portions of Lots 4 and 5, Block K Greenway, for a tank site for the Bureau of Water Works, and authorized the City Attorney to commence condemnation proceedings for acquisition thereof; that subsection a of Section 3 of said ordinance failed to set forth the amount of the purchase price of said property and should be amended to state the amount as \$40,000; now, therefore, subsection a of Section 3 of Ordinance No. 134510 hereby is amended to read as follows:


a. Warrant payable to the Clerk of the Court of Multnomah County for the benefit of Raymond T. Bolger and Mary E. Bolger in the amount of \$40,000 plus City's pro rata share of property taxes as of the date of acquisition or possession, whichever comes first, as determined by the Court;

Section 2. All other provisions of Ordinance No. 134510 shall remain in full force and effect.

Section 3. Inasmuch as this ordinance is necessary for the immediate preservation of the public health, peace and safety of the City of Portland in this: In order that there may be no unnecessary delay in acquiring the property needed for public use; therefore, an emergency hereby is declared to exist and this ordinance shall be in force and effect from and after its passage by the Council.
