ORDINANCE NO. 131978

An Ordinance amending Section 20.20.010 of the Code of the City of Portland by addition to and deletion of playing rates involving annual commutation tickets for the playing of golf on the city-owned golf courses, and declaring an emergency.

The City of Portland ordains:

Section 1. The Council finds that it has been recommended by the Golf Advisory Committee that the paragraph on annual commutation tickets permitting unlimited play be changed in certain respects so as to add the category that will include the spouse and establish rates therefor, and increasing the fees for 9 holes of play and adding an additional category for 18 holes of play and establishing rates therefor; that the Committee's recommendation has been recommended for adoption by the Superintendent of Parks and the Commissioner in charge; now, therefore, Section 20.20. 010 of the Code of the City of Portland, in the second paragraph which establishes the rate for annual commutation tickets hereby is amended to read as follows:

20.20.010. PLAYING RATES. The following rates shall be charged and collected for the privilege of playing golf on the Eastmoreland, Rose City, Progress Downs and West Delta Golf Courses:

For each round of nine holes or less, on week days	\$1.75
For each round of nine holes or less, on Saturdays, Sundays and holidays	2.50
Except that an 18-hole ticket on Sat- urdays, Sundays and holidays may be purchased for	4.50
For players who hold a valid member- ship card in the city Junior Golf Club and who have passed their ninth birthday but who have not passed their eighteenth birthday, the rate for nine holes shall be	.75
This "funior" rate shall not apply	

until after one o'clock p.m. on any

Saturday, Sunday or holiday.

For college golf team members during intercollegiate tournament competition only for each nine holes or less

1.00

The rate for annual commutation tickets permitting unlimited play on any day of the year and valid from July 1 of each year to June 30 of the following calendar year shall be seventy dollars and for the spouse of such ticketholder a fee of fifty-five dollars will be charged, and in addition the holder of such ticket or tickets shall pay a greens fee of \$2.25 per eighteen holes of play, or \$1.25 per nine holes of play on weekdays, and on weekends and holidays the greens fees shall be \$2.50 per eighteen holes of play or \$1.75 per nine holes of play.

* * *

Section 2. Inasmuch as this ordinance is necessary for the immediate preservation of the public health, peace and safety of the City of Portland in this: In order that the changes in the new rates be made effective for the 1972-73 fiscal year; therefore, an emergency hereby is declared to exist and this ordinance shall be in force and effect from and after its passage by the Council.
