

ORDINANCE NO. 135737

An Ordinance amending Section 4.16.085 of the Code of the City of Portland, Oregon, relating to holidays, and declaring an emergency.

The City of Portland ordains:

Section 1. The Council finds that in enacting Section 4.16.085 of the City Code it was its intention to provide personal holidays only to employes not covered by a collective bargaining agreement or where that benefit was in accord with a collective bargaining agreement; and that said section should be amended to specifically reflect this intention; now, therefore, Section 4.16.085 of the Code of the City of Portland, Oregon, hereby is amended to read as follows:

4.16.085 PERSONAL HOLIDAYS.


Unless otherwise provided in a collective bargaining agreement, full-time employees are entitled to one personal holiday in 1972 in addition to the holidays provided under Section 4.16.080. Each calendar year thereafter, full-time employees represented by the Portland Police Association are entitled to one personal holiday and all other full-time employees are entitled to two personal holidays. A personal holiday may be scheduled only:

- (a) After six months of continuous City service;
- (b) At the mutual convenience of the employee and the department; and
- (c) During the calendar year in which it accrues.

Section 2. Inasmuch as this ordinance is necessary for the immediate preservation of the public health, peace and safety of the City of Portland in this: In order that the intention of the Council in providing personal holidays may be specifically reflected in Section 4.16.085 of the City Code without unnecessary delay; therefore, an emergency hereby is declared to exist and this ordinance shall be in force and effect from and after its passage by the Council.
