

## ORDINANCE No. 187879

\* Authorize health and welfare contract administered by the Bureau of Human Resources, Health & Financial Benefits Office with Express Scripts, Inc. for Pharmacy Benefit Management effective July 1, 2016 through June 30, 2021. (Ordinance)

The City of Portland ordains:

Section 1. The Council finds:

1. The Office of Management and Finance, Bureau of Human Resources requires the continuing provision of employee health and welfare administration.
2. In order to maintain employee health and welfare benefits on behalf of employees, retirees, COBRA and other self-pay participants and their eligible dependents, and to maintain access to prescription medications for all self-insured plan participants it is deemed appropriate and necessary to authorize the services of Express Scripts as the City of Portland Prescription Benefit Manager.
3. The Office of Management and Finance, Bureau of Human Resources has worked collaboratively with the LMBC on this contract and plan design recommendations for the City's self-insured plan, as modified within the City of Portland Employee Benefits Program.

The Health Operating Fund has sufficient appropriation in support of the benefit and the contract listed above.


NOW THEREFORE, the Council directs:

- a. The Mayor or Director of Human Resources is hereby authorized to execute the contract and any subsequent renewals during the term of the contract in a form substantially similar to the attached Exhibit A and B attached.
- b. The Mayor and the Auditor are hereby authorized to draw and deliver warrants not to exceed the amounts listed in Exhibit A.

Section 2. The Council declares that an emergency exists in order to avoid undue and costly delay in providing benefits to plan participants; therefore, this ordinance shall be in full force and effect from and after its passage by Council.
