ORDINANCE No.

* Authorize two-year grant agreements with seven organizations for programming for at-risk youth in partnership with Portland Parks & Recreation under the Mayor's Community Center Initiative in an aggregate amount not to exceed \$700,000 (Ordinance)

The City of Portland ordains:

Section 1. The Council finds:

1. In 2015, the Portland Police Bureau reported 183 gang shootings in our community. Portland is on pace for another record year in 2016. To help address this phenomena, Mayor Hales has established a Community Center Initiative to provide pro-social activities for at-risk youth in safe and supportive environments.
2. As part of the Mayor's Community Center Initiative, Portland Parks & Recreation (PP&R) shall provide grant funding to organizations that deliver the aforementioned services.
3. The Mayor's Office, Commissioner Fritz Office, and PP&R jointly solicited grant proposals from a number of organizations.
4. The Mayor's Office, Commissioner Fritz Office, Office of Youth Violence Prevention, and PP&R have reviewed the proposals, and recommend that two-year grants be awarded to selected organizations in an aggregate amount not to exceed \$700,000.
5. For Fiscal Year 2016-17, the aggregate amount of grant funding that will be allocated to selected organizations is not to exceed \$350,000. The specific amounts were determined during the FY 2016-17 budget process.
6. For Fiscal Year 2017-18, the aggregate amount of grant funding that will be allocated to selected organizations is not to exceed \$350,000. However, the availability and amount of this funding will be determined during the FY 2017-18 City budget process.

NOW, THEREFORE, the Council directs:

- a. The Director of Portland Parks & Recreation is authorized to execute the attached grant agreements, as approved to form by the City Attorney, on behalf of the City of Portland, with Portland Opportunities Industrialization Center (POIC), Immigrant & Refugee Community Organization (IRCO) – Africa House, Latino Network, Native American Youth and Family Center (NAYA), Boys & Girls Club of Portland Metropolitan Area, Self Enhancement, Inc. (SEI), and REAP, Inc., and the Director or the Director's designee is authorized to take all actions on behalf of the City provided in the grant agreements.

- b. The Director and City Auditor are hereby authorized to pay the grant amounts stated in the agreements, to the extent such funds have been allocated in PP&R's Budget.

Section 2. The Council declares that an emergency exists because delay in the execution of the grant agreements will unduly jeopardize the availability of programming for at-risk youth, particularly in the summer months; therefore, this ordinance shall be in full force and effect from and after its passage by the Council.
