## 187891 ORDINANCE No.

Authorize an Intergovernmental Agreement with the State of Oregon on behalf of Portland State University to provide selected students with the opportunity to earn scholarships and stipends while working at the Bureau of Development Services FOR \$51,885 (Ordinance)

The City of Portland ordains:

## Section 1. The Council finds:

- 1. BDS has a need to increase diversity amongst the planners it employs to better align with the City of Portland's Racial Equity Goals & Strategies.
- 2. BDS and PSU will work together to provide selected PSU students who meet diversity qualifications with the opportunity to earn scholarships and stipends while working at BDS. Students will be assisting development review planners in the administration of the zoning code. BDS agrees to contribute to PSU to help fund the scholarships, stipends and administrative costs as described in the Intergovernmental Agreement (Exhibit A) and Scope of Work (Exhibit B).
- The cost for BDS for FY2016-17 will be \$17,295 per student intern. This 3. provides a scholarship and stipend for the student and covers the cost for PSU to administer the program. The total yearly cost for 3 student interns to BDS for FY2016-17 will be approximately \$51,885 as described in Exhibit C.
- 4. Funds for this IGA are available in the BDS FY2016-17 budget.

## NOW, THEREFORE, the Council directs:

- a. The Director of the Bureau of Development Services is hereby authorized and directed to execute the IGA with the State of Oregon, acting by and through the State Board of Higher Education, on behalf of Portland State University (PSU).
- b. The Council authorizes the Director of the Bureau of Development Services to renew this IGA for up to three years ending no later than June 30, 2020.
