\*Pay claims of Aleksey Protopopov and David Kovalenko for the total sum of \$21,689 involving the Portland Police Bureau. (Ordinance)

The City of Portland ordains:

ORDINANCE No.

Section 1. The Council finds:

- 1. Aleksey Protopopov and David Kovalenko and their insurance carrier Pemco Insurance have filed bodily injury claims against the City for damages suffered in a motor vehicle accident with the Portland Police Bureau on July 8, 2014.
- 2. The claims have been investigated by Risk Management Services. The investigation indicates there is risk the City may be found liable. Therefore, in order to avoid the risk of an adverse jury award, we feel it is prudent to compromise the claims at this time.
- 3. Risk Management Services and the City Attorney's Office recommend the claims be compromised for the total sum of \$21,689.20, subject to the claimants providing the City with a release in a form to be approved by the City Attorney. Risk Management has already paid \$5,000 of this total to Mr. Protopopov, and \$5,000 of this total to Mr. Kovalenko.

NOW, THEREFORE, the Council directs:

- a. The Mayor and the Auditor are hereby authorized to draw and deliver two checks: one in the amount of \$5,661.50 payable to Pemco Insurance (for medical expenses of Aleksey Protopopov); and a second check in the amount of \$6,027.70 payable to Pemco Insurance (for medical expenses of David Kovalenko). Combined with the \$10,000 already paid to Protopopov and Kovalenko, the total value of these two injury claim settlements is \$21,689.20.
- b. Risk Management Services will execute payment authorizations in the amount set forth in sub-paragraph (a) above.
- Section 2. The Council declares that an emergency exists in order to avoid undue and costly delay in settling these claims; therefore, this Ordinance shall be in full force and effect from and after its passage by the Council.


