## RESOLUTION No. 37226

Direct the City Engineer to waive City Code upon receiving evidence to support a proposal to rename SW 9<sup>th</sup> Ave from W Burnside St to SW Montgomery St to Park Ave and allow the Portland Bureau of Transportation to process the street renaming application in good faith. (Resolution)

WHEREAS, the Portland Bureau of Transportation received a street renaming application for SW 9<sup>th</sup> Avenue to be renamed "Park Avenue" with 75% support of abutting property owners; and

WHEREAS, 9<sup>th</sup> Avenue is non-contiguous with segments in the SW hills, a segment north of Burnside which turns into NW Park and changes again north of Glisan to NW 9<sup>th</sup> again; and

WHEREAS, the street renaming application is not seeking to rename the street after a prominent person; and

WHEREAS, the Bureau of Transportation wishes to process the application in good faith, with Code defined outreach procedures, historian panel, and Design Commission input to make the determination if the street can be renamed under Portland City Code; and

WHEREAS, beyond the sections of 17.93 referenced above, the street does fit the criteria outlined in City Code and the applicant has demonstrated support of adjacent properties.

NOW, THEREFORE, BE IT RESOLVED, that the City Engineer shall, upon receiving evidence to support a proposal to rename this portion of SW 9<sup>th</sup> Avenue as SW "Park Avenue" waive Portland City Code Subsections 17.93.010 A. and 17.93.020 C. If the submittal is in compliance with all other criteria outlined in Section 17.93 issue and consider application materials in accordance with the Code.


