\*Amend contract with CH2M Hill Engineers, Inc. for additional work completed for the Smart Cities Challenge grant project in the amount of \$10,000 and allow for final payment (Ordinance; amend Contract No. 31000660)

The City of Portland ordains:

## Section 1. The Council finds:

- In January 2016, Portland Bureau of Transportation (PBOT) also engaged the services of CH2M to assist with the submission of Portland's Smart City Challenge grant due February 4, 2016.
- 2. Portland was selected as a finalist city for the grant on March 12, 2016 and received a grant of \$100,000 to be used to revise the grant application with the final application due May 24, 2016.
- 3. PBOT revised its contract with CH2M to assist with a large portion of the grant application to continue this work on the aggressive timeline.
- 4. In order to complete the work for the Smart City Challenge grant, PBOT amended the contract through Ordinance No. 187734 to provide for this budgeted and planned work on May 11, 2016.
- 5. On May 24, 2016, PBOT submitted the application to both United States Department of Transportation, (USDOT) and Vulcan for the Smart City Challenge and followed with a presentation to USDOT on June 9, 2016.
- 6. Portland, though not selected, was within the top tier of candidates and has developed a compelling proposal to compete for grant funds.
- 7. Through June and July, PBOT has partnered with public and private entities to submit grant applications. PBOT has partnered with: the Oregon Department of Transportation to seek grant funds for elements related to Columbia Boulevard; TriMet to seek grant funds for elements related to the Mobility Marketplace, and; PBOT has work with an AT&T consortium to fund elements related to 122<sup>nd</sup> Avenue.
- 8. The Bureau's level of confidence in the cost estimates for this project is high because the amendment allows for the final payment in order to close out this contract.

NOW, THEREFORE, the Council directs:

 That the Commissioner-in-Charge is hereby authorized to execute the contract in a form similar to the contract attached as Exhibit A

Section 2. The Council declares that an emergency exists because the work is completed and final payment allows for the closure of this contract; therefore, this Ordinance shall be in full force and effect from and after its passage by the Council.
