Terminal 1 testimony

 First off, there is a two hundred and fifty million dollar housing bond on the table which will create 1300 units. Homer is going to accommodate the same amount of people using less than fifty million in public funds. Consider how we offer homeless a years' worth of free rent in the TPI building, and how we subsidize the rents of so many more who would otherwise be homeless. Homer is taking pressure off of this system of offering everyone their own individual unit by any unsustainable means necessary and in the long run is saving the city a LOT of money.

If the numbers reported by the Oregonian were correct and this place could operate off of 132,000/ month then charging just the 700 on the transitional housing side \$200/ month would make it more than break even.

Thus it is stupid we're debating market rate leases. The term 'ratepayer' itself is both demeaning and misleading; as if many homeless have not paid for these services throughout most of their lives.

 Separately from this, I very support the preservation of this type of infrastructure in the river district as group identity, confidence, culture, community, as well as a place that is within reach where you can clean up and find a safe and warm nights rest can all be important things when in this situation.

However, consider why you pay rent. It means you have autonomy, 24/7 access, and responsibility. You go through applications to determine whether you would be a responsible tenant, and when you cause a disturbance or damage the property you get evicted. In missions however both screening and accountability are mostly missing. Hence when someone gets drunk and damages the property, or sneaks out to deal drugs these things backfire on everyone. Suddenly no one can be there during the day, full grown adults are given a curfew, and when you come in for at night you must stay put until getting kicked out at 6 am.

Though missions are necessary, what is missing is an effective filter capable of differentiating between those who need help and those who simply need options. Right now our options are to pay more than we can afford for our own unit, to be criminalized and on the run outside, or to be treated like prisoners in a mission. I hope the city, homer, and anyone else involved in running the campus consider this in regards to both the mission and transitional housing side of this campus.

As a homeless man, I would really only trust the place if and when it is offered as an honest rental. I don't want your help or charity, I want options and my own freedom.

MIT graduate has shown the primary cause of inequality over the last fifty years is housing.

Washington post reports the numbers simply don't add up when trying to offer everyone their own individual unit.

The bottom line is privacy and offering everyone their own individual unit limits the number of people paying rent per square foot.

Dear Portland City Council,

I apologize for the multiple emails, but wanted to follow up after receiving a response from Commissioner Saltzman who stated that the Council has done it's due diligence by reviewing over 120 possible sites to provide services to the homeless. It was stated that the majority <u>(but not all)</u> of the sites were ruled out. Certainly there are viable alternative that may be a better option for services to the homeless than terminal 1.

I am wondering, if the city is prepared to apply for a grant to research shelter options for the homeless, why is the grant strictly limited to a feasibility study at terminal 1 and forgo any opportunities for alternatives that may provide better options for homeless services? Since Homer Williams has generously offered funds to assist Portland's homeless, surely this offer is not contingent on a single site, but is meant to truly address core issues causing homelessness.

I ask that the grant request not limit the study to terminal 1 and include and review of additional sites that could provide services to the homeless for the best possible outcome.

Dear Portland City Council,

Thank you for this opportunity to provide comments regarding the Council's consideration of authorizing a grant proposal of \$100,000 for a feasibility study of a mass homeless shelter to be located at terminal 1. The proposal limits the study to the Terminal 1 site. If Portland is considering a mass shelter as an option for Portland's homeless, a study for a mass shelter should include an impact analysis with multiple site options to ensure that the shelter will have the best chance of success. Authorizing a study to consider only one possible location not only limits the probability of success, but ignores the financial, community, environmental, health and safety considerations of such a massive project.

Additionally, the analysis is limited to the study of mass shelter. The study should include an analysis of other options to the mass shelter. Would funding smaller, resource focused shelters and housing opportunities be a better use of these funds? I know of no business that would undertake such a large project, without a thoughtful analysis of options and urge the City Council to act in the best interest of the community in which they serve and ensure that a feasibility study for a mass shelter include multiple options for consideration.
