Appoint Neil Simon, Marisea Rivera, and Roberto Rivera to the Citizen Review Committee advisory board to the Independent Police Review, a division of the City Auditor's Office. (Resolution)

WHEREAS, the City Council adopted Ordinance 175652, June 6, 2001, establishing the Independent Police Review and the Citizen Review Committee;

WHEREAS, an eleven-member Citizen Review Committee is responsible for ensuring impartial hearings of appeals, participating in public outreach efforts, and providing an advisory role to the Independent Police Review;

WHEREAS, the committee has three vacancies resulting from the completion of terms by one member and the resignation of two members;

WHEREAS, a Selection Committee consisting of three Citizen Review Committee representatives, two members of the community, and the Assistant Program Manager of the Independent Police Review recommended three applicants to serve of the Committee;

WHEREAS, the City Auditor nominated the three recommended members to City Council;

NOW, THEREFORE, BE IT RESOLVED, that the City Council for the City of Portland, Oregon appoints to the Citizen Review Committee new member Neil Simon, Marisea Rivera, and Roberto Rivera for a three-year term that will begin August 31, 2016 and end August 16, 2019.




